This application seeks to amend FTA grant OR-03-0049 to provide additional Fixed Guideway Modernization funding for the Banfield Communications Retrofit project (\$1,090,000 total; \$872,000 federal.) Funding to expand the Rose Quarter Light Rail Station platform (\$325,000 total; \$260,000 federal) is also requested.

All projects have been selected through Tri-Met's planning process, which incorporated public involvement, and are programmed in the Metropolitan Transportation Improvement Program.
