# TYSON APOLOGIZES, **CAREER IN** LIMBO

Mike Tyson, disqualified for biting Evander Holyfield's ears in their heavyweight title fight, faces a formal complaint alleging unsportsmanlike conduct and bringing boxing into disrepute, prosecutors said Tuesday.

An emergency hearing of the Nevada State Athletic Commission voted unanimously to hold a disciplinary session next week at which the fighter could be heavily fined and or receive a lengthy ban from boxing.

In the meantime, he is temporarily suspended and his nearly \$30 million purse from Saturday's fight is being withheld.

"Mike is serious about this, he will place his fate in their hands," Tyson's lawyer, Eckley Keach, told reporters after Tuesday's public hearing. "Mike is willing to accept whatever the commission determines."

Tuesday's meeting of the fiveman commission began with a playing of the videotape of the World Boxing Association bout in which Tyson was disqualified for biting Holyfield twice in the third round.

Holyfield, who had beaten Tyson in their first bout in November, required 15 stitches in his right ear and will have to undergo reconstructive plastic surgery to repair a hole in the top of it. His left ear was extensively chewed, but there was no permanent damage, doctors said.

The champion's lawyer has said he has not ruled out filing civil charges against Tyson for the bites.

After watching all three rounds of the fight and the ensuing melee in the ring after the disqualification, commission member Jim Nave read a motion formally asking for the District Attorney's office to draw up a complaint against Tyson. The commission ordered the fight's promoter, Don King Productions, to provide a check for \$29,824,600, representing Tyson's purse, to be deposited in an interestbearing account pending the outcome of the hearing. Once the Nevada attorney general's office drew up a formal complaint, a period of three working days must pass before the hearing may be held. That would set the hearing for next Tuesday or Wednesday at the earliest, since the July 4 Independence Day holiday is observed on Friday.

# **NBA** free agency period begins

One year after a free agent frenzy enabled three NBA players to crack the \$100 million barrier, the 1997 market will not quite reach the same high-rent district. Superstar Michael Jordan of the Chicago Bulls and Patrick Ewing of the New York Knicks headline the list of NBA players who become eligible for free agency on Tuesday. Last July, Jordan, Shaquille O'Neal, Alonzo Mourning, Juwan Howard, Gary Payton and Reggie Miller flooded the market with an all-time collection of marquee players. Jordan ended up signing a one-year contract worth a record \$30 million, the highest annual salary in the history of sports.
