The proposed work consists of: placement of approximately 760 cubic yards of unclassified excavation, 320 cubic yards of backfill, 220 cubic yards of Class 700 riprap, 460 cubic yards of gabion construction, and appurtenant work.

Any objections to or comments upon the bid specifications must be submitted in writing to the Public Works Department, Room 325, 555 Liberty Street, SE, Salem OR 97301-3503. They must be received no later than ten (10) working days before the bid opening date.

A surety bond, cashier's check or certified check of the bidder, in the amount of ten percent (10%) of the bid must be attached to each proposal as security. Unsuccessful bidders will have their security refunded to them when the contract has been awarded.

No bid, **Exceeding** \$2,000, will be received or considered by the City of Salem or any of its officers unless the bid contains a statement by the bidder (by signing his/her proposal) that the provisions of the Davis-Bacon Act (40 U.S.C. 276a) shall be included in his/her contract. Every Contractor or subcontractor **is required** to post the applicable prevailing wage rates in a conspicuous and accessible place in or about the work-site for the duration of the job.
