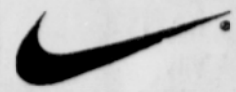

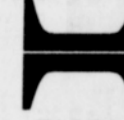

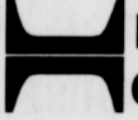

You have important legal rights and you must take steps to protect your interests.
