A "Street of Dreams And A Village For Sale" 111

A definite shock wave was created when I 'dared' to comment on the mind-set of "Lewis Mumford," America's most revered urban planner; "A major figure in architecture, planning and social thought" (Norman Cousins, Herbert J. Gans).

As an African American, a member of the group most economically and socially devastated by that pantheon of cruel dreamers who provided us with a "Geography of Nowhere" e.g. "Urban Renewal-I stand fully able and qualified to criticize the inhumanity of America's man-made landscape, and sometime, the philosophies and philosophers who created it.

Last week, I quoted a white professional who spoke of my comments on a contradiction or dichotomy in the psyche of the whites who first fought desperately to flee the city centers-but who now fought equally as hard to return from suburbia, the promised land.

I said that, "Even the renowned urbanologist, Lewis Mumford was so afflicted." For a summary of his contradictions one need to look no further than pp. 6, 7 of the introduction of that classic, "The Lewis Mumford Reader" (Donald L. Miller ed. Pantheon 1986).

"His ideal community is one that combines the dynamism and diversity of the city with the values of the village-order, neighborhood stability and community closeness...but he (Mumford) has lived half his life in a reconverted farmhouse in a "Walt Whitman simplicity in the quiet village of from the city in which he grew

Of course, the black people of the nation had to some extent enjoyed the values of the village, order, neighborhood stability and community closeness-tightly enforced by the National Association of Realtors and by Restrictive Covenants. Sometimes by police and the National Guard.

African Americans therefore, were 'imprisoned' in their ghettos as were the Jews in Venice, Italy in their confinement to an island section officially named "Ghetto." But Jews did have economic liaisons with kin in other countries, and were able to 'break

Though the blacks, whenever, able developed the humanities and social infrastructures I have described here in such series as "Family Matters: The Way It Was. Their land and infrastructure was greedily devoured by the 'urban renewal' specialist (removal).

As I said here earlier I created a shock wave, daring to critique a god in the urban pantheon, but I always have my documentation. I am reminded of the time I assailed the alleged findings of Margaret Mead in her classic 1928 book, "Coming of Age In Somoa," Morrow Quill, 1961.

The Darwinists leaped right on this 'proof' of all the sexual myths about dark skins="corrobroates through practical demonstration, the psychosexual theories promulgated by Freud and his pupil" (DR. A.A. Brill). My Samoan students at PSU (urban economics class) had brought this matter to my attention during a break and introduced me to a work based upon years of research by an Australian professor, Dr. Freeman.

His book, "Margaret Mead and Samoa: The Making and Unmaking of an Anthropoligical Myth," (Harvard, 1983), completely refuted Mead's findings of the same type of "cultural determinism" that American Welfare Systems use to describe the black poor. When I pointed out the schizophrenia in the makeup of the planners there were equal screams of outrage. So be it.

This 'Mead-reference' is not really a departure from the main theme here, for it is absolutely necessary to understand that it is highly resented by the majority population when blacks 'dare' to make critical assessments of the gurus who control their economic

and social welfare. The suburban developers are reaching for picket fences, large porches, small yards, public squares and narrow streets. Will this marketing ploy sustain a continued "white flight?" And the cities play new games with the infrastructure, cramming, jamming, and manipulating codes (needed sewers, water

Are there really going to be any "Streets of Dreams" that anyone can afford or safely trod? In any of the new environs, near or afar? Can a real "village" come to exist simply by saying so in a huge display ad? Can the warmth and amenities of neighborhoods be established by fiat? (because I say so). It will be interesting people and politics.

Wildland fire danger grows

Recent warm, dry weather has created a potential for fires in local fields and woodlands that could threaten homes and businesses.

According to John Gentry of the Vancouver Fire Department (VFD), residents in neighborhoods abutting wooded areas should take steps to protect their property by establishing a "defensible space" around building. The space should provide a buffer between buildings and combustible materials, including dry vegetation.

The VFD Fire Prevention Bureau has also increased its emphasis on abatement of hazardous vegetation in neighborhoods. So far

this summer, over 150 property owners have been contacted by the fire department regarding eliminating these fire hazards.

Some specific ways to create a fire-safe buffer zone in wooded or grassy areas include:

*Mowing and raking field grass. *Removing dead, woody materials from the ground near build-

*Removing low limbs and shrubs that a fire could climb into treetops *Reducing potential fuel through
