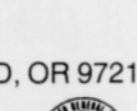

The University of Oregon, located in beautiful Eugene, Oregon, encompasses 279 acres and 4.5 million square feet of buildings. We are looking for an individual with excellent interpersonal skills and a record of outstanding performance in areas related to developing a university's physical environment, including architecture, landscape architecture, and planning. This position primarily manages individual projects through the design phase. This includes researching and assembling background materials and site specific information; working with user groups to develop program materials; assisting in the creation and management of project budgets; and serving as the central point of contact for project parties.
