## Brain Imaging used in psychiatric research

Houston, TX-Two brain-imaging techniques might lead to improved diagnoses and treatment of psychiatric illnesses such as schizophrenia and bipolar disorder.

"In psychiatric research, we are using standard magnetic resonance imaging (MRI) scanners to look at brain activity and brain-chemical concentrations," said Dr. Kathryn Kotrla, a psychiatrist a Baylor College of Medicine in Houston.

The techniques, called functional MRI and magnetic resonance spectroscopic imaging (MRSI), give physicians the opportunity to compare

patients with different psychiatric disorders hope to learn more about the brain areas involved in various psychiatric illnesses.

"These non invasive tests let us look at how an illness is changing with time, how it is responding to medication, or how brain function changes with different symptoms," said Kotrla, who also is chief of psychiatry at Ben Taub General Hospital.

Over the years, neuroimaging research has identified which areas of the brain are wired for feeling, thought, behavior and memory. Patients with psychiatric illnesses often experience disturbances in these areas. Kotrla is studying brain images of patients with schizophrenia and bipolar disorder, also called manic-depression. "Schizophrenia and bipolar-disorder patients often become psychotic," Kotrla said. "With brain imaging, we can see if the same area of the brain is involved with that symptom in these different illnesses."

Learning more about the brain areas involved in various psychiatric illnesses might one day lead to quicker diagnosis and to a better way to determine which medications are

best for each patient.

"In the future, we may be able to use functional MRI and MRSI to rapidly access whether someone's first psychotic episode is linked to bipolar disorder or schizophrenia and bipolar disorder, Kotrla also is involved in imaging studies of attention deficit hyperactivity disorder and autism. Baylor's neuroimaging technology is provided through a collaboration with the National Institute of Mental Health.

"Brain-imaging research can help people realize that mental illness is a medical illness," Kotrla said.

### Little Grants Mean A Lot

Commissioner Gretchen Miller Kafoury announced that a total of fourteen projects, totaling \$161,458, were chosen to be funded through the Bureau of Housing & Community Development (BHCD) Community Initiatives Small Grant. This program is supported through the federal Community Development Block Grant Fund.

In making her announcement, the Commissioner praised the Community Initiatives Program for having provided over \$1.75 million to more than 160 community-based projects, in its seven and one half years of operation.
"The Community Initiatives program," said the Commissioner,
"is a great example of what community development is all about."
"It is amazing how citizens can take such a small amount of city money and accomplish so much good in the community."

Highlights of the most recent evaluation of the Community Initiatives program include:

. Over 92,000 hours of volunteer labor were used by projects.

. More than 1,600 community groups and neighborhood businesses participated as project

partners

. The value of non-city resources, including cash, donated goods and services, and volunteer labor, for completed Initiatives projects totals almost \$2.5 million in non-city resources, representing 183% of the Community Initiatives funds given to those projects.

. Almost 10,000 clients have been served by funded projects.

The purpose of the Community Initiatives Small grant program is to encourage and support community-based programs in meeting the basic needs of low income persons and/or assist in the revitalization of low income neighborhoods. The Program supports citizen-based initiatives using a self-helpmodel of people helping people by making small one-time grants to non-profit and neighborhood organizations and requiring significant matching support.

# Mixed-Income Multifamily Housing a Reality

PORTLAND, OR—Affordable housing in the River District for working families in Portland is one step closer to reality thanks to the efforts of Mayor Vera Katz, the union Station Phase II Development Team, and Fannie Mae (FNM/NYSE0, the nation's largest source of home mortgage funds and multifamily financing. Fannie Mae provided credit enhancement for \$23 million of bonds issued by the city of Portland for Phase II of yards at Union Station. Green Park, Financial, a member of Fannie Mae's Delegated Underwriting and Servicing (DUS) team of lenders, helped arrange the financing on this development. "Know Your Rights in Christ" is a product and marketing campaign which utilizes the widespread popularity of the Miranda Act to proclaim the "rights" an individual has in the context of a relationship with Jesus Christ. "We are a culture that is obsessed with an individual's legal rights," said Mr.

Pierce. "We need to understand that we will never be able to obtain the peace and security we are looking for solely through legislation and legal battles. We need to go to the source of all freedom and truth to find our peace. Once we become slaves to Christ, then we will truly be free."

Mr. Pierce is committed to the truth that true reconciliation between the races can only come when the human race reconciles itself to God. Based on passages like Colossians 3:11, Mr. Pierce preaches a message of racial reconciliation that is rooted in the truth that it is in Christ that we become one and no where else. "True racial harmony cannot be achieved by moving from the outside to the inside," said Mr. Pierce. "We will only truly see each other as equals when we are united by the shed blood of Christ."

Fire Chief Robert Wall has appointed Donny R. Adair to serve as the Human Resources Manager for Portland Fire and Rescue.


