Cluster development focus of open houses

Vancouver, WA — Clark County holding two open houses on a proposed ordinance dealing with cluster development on lands zoned Rural 5, 10, or 20. the ordinance would stipulate the requirements and limitations of cluster developments in these areas and would affect how property owners could develop their

The open houses are scheduled as follows:

Tuesday, January 12, 6 to 8 p.m., Mt. Valley Grange, 40107 NE 221 Ave., Amboy

Thursday, January 14, 6 to 8 p.m., Tri-Mountain Golf Course, 1701 NW 299th Street, Ridgefield

The citizens' Agri-Forest Task Force, which had worked with Clark County in 1997 and 1998 on zoning issues in rural and resource areas, recommended that the county develop a cluster ordinance. Cluster development allows for residents to be placed on parcels smaller than the minimum lot size in exchange for retaining the majority of the site as undeveloped open space.

Key components of the ordinance, which was formulated by county staff and reviewed by the Agri-forest Task Force, are:

Applicability: Cluster development would be allowed only on lands that are currently zoned Rural 5, 10

Density: Within the Rural 5 and 10 districts, the base density is one unit per five acres. Within the Rural 20 district, the base density is one unit per ten acres with the ability to go to one unit per twenty acres if certain enhancements are under-

Open space parcel requirements: At least 8 acres and a minimum of 75 percent of the site must be established as an open space parcel. The parcel shall contain sensitive lands (wetlands, steep slopes, habitat areas, ect.) and shall service to buffer adjacent resource lands. Limited uses are allowed; they do not include a single family residence, either existing or new. A management plan must be approved for the site.

Cluster lot requirements: Siting standards are proposed to minimize visual, environmental, and resource lands impacts. Cluster lots cannot include sensitive lands. Lots cannot be less than 18,000 square feet nor greater than two acres. Setbacks are established to maintain minimum separation between buildings and streets, other structures, and designated resource lands. Other design elements to maintain rural character are also required.

The open houses are an opportunity for residents to learn more about the draft proposal and to offer their comments and suggestions to county
