Heroin Trafficking Targeted By Portland Police Precincts

For the past two months street officers from all of Portland's five patrol precincts have been conducting an undercover investigation of street level heroin dealers who have been plaguing downtown and lower southeast Portland. As a result, on Wednesday morning January 6, 1999, officers executed eight search warrants of residences in the Portland metropolitan area and sought consent to search eight other homes and businesses. Additionally, twentynine (29) people have been taken into custody for Delivery of a Controlled Substance (DCS) and Possession of a Controlled Substance (PCS). Officers are currently seeking another 12 to 15 individuals for drug related charges. When located they will be arrested and charged for their participation into the infusion of tar heroin into Portland in recent months.

In early November, 1998, Central Precinct officers began an investigation into street level heroin dealing in the Burnside area of

downtown Portland after officers noticed an influx of new drug suppliers. Through a series of arrests, street contacts and information received from informants, officers found many of the new suppliers were Honduran who were selling tar heroin around the Burnside area on both the West and East sides of the Willamette River. Further, officers found that many of the dealers they were surveilling were found to frequent two restaurants on East Burnside which were identified as the La Casita, 436 E. Burnside St, and Tequila Pepper's, 830 E. Burnside St.

It was found that officers from Southeast Precinct had simultaneously begun an investigation into drug dealing emanating from La Casita and Tequila Pepper's. Officers from Central and Southeast Precincts formally combined their investigations and initiated a series of surveillances and under cover hand to hand drug buys on the streets of Portland and in the La Casita and Teguilla Pepper's

restaurants. Efforts have been made to link the known street level heroin dealers to their suppliers.

On January 6, 1999, Wednesday, Portland officers, with the assistance of the Multnomah County Sheriff's Office, the Clackamas County Sheriff's Office, the Oregon State Police, the Gresham Police Department, the Washington County Interagency Narcotics Task Force (WIN), the Oregon Liquor Control Commission (OLCC) and the Immigration and Naturalization Service (INS) simultaneous searched several residences for tar heroin and cocaine and in the process took twenty-nine (29) people into custody for Delivery and Possession of tar heroin and cocaine. Officers are seeking 12 to 15 additional suspects who are known to be involved in the distribution of drugs in Portland.

Unknown quantities of suspected heroin, cocaine and cash were seized from several of the searched locations.

City Invites Applications For Charter Review Committee


Applications will be accepted by the Mayor's Office Through Jan. 25, 1999 for fifteen positions on the Charter Review Committee, per Section 11.17 of the Vancouver City Charter.

"No later than five years after the most recent charter review, the mayor shall appoint, subject to city council confirmation, a panel of fifteen residents to review the city charter and to recommend to the

city council in time to be considered for the year's election, any charter changes or amendments which the panel believes should be put to a vote to the people, and the council shall thereafter place any such amendment on the ballot at the next municipal election if a majority of the city council so determine; provided nothing herein shall interfere with the right of citizens to, by petition, require an election to be held

for any charter amendment or to cause a freeholder election to be held for a proposed new city charter, nor shall it interfere with the right of the city council to, at anytime, propose and submit proposed charter amendments to the voters."
