## Revenue Department Mailing Out Federal Retirement Refund Checks

The Oregon Department of Revenue is in the midst of mailing refund checks to eligible retired federal employees and their beneficiaries. Many recipients already have received their checks and other are on their way.

"We are very pleased that these refund checks are in the mail and will be in the hands of federal retirees and their families," said Ben Gille of the department. "We know all retirees have been waiting for these refunds for quite awhile."

Gille advises those who have not received a check to be patient. "We've received thousands of verification forms and we will continue to process refunds for the next few months."

He reminds those eligible to receive a refund to send in a verification form as soon as possible if they already haven't done so. Federal retirees and their beneficiaries must accurately complete and return verification forms provided by the Department of Revenue. Eligible federal retirees can get the forms by calling 503 378-4988, or toll-free in Oregon 1-800-356-4222 (January through April only). For TTY (hearing or speech impaired only), the year-round toll-free number within Oregon is 1-800-886-7204. In Salem the number is 503-945-8617. These numbers are answered by machine only and are not for voice use. Telephone hours are Monday-Friday, 7:30 a.m. to 5:10 p.m., exept Wednesday when the hours are 9:00 a.m. to 5:10 p.m.

The verification forms and instructions also are available on the department's Web site at www.dor.state.or.us

The information needed on the form includes number of months worked before and after October 1, 1991, and federal pension amounts for each affected year. Civilian federal employees who receive a pension from the U.S. Office of Personnel Management and are unsure of their service months may contact the Revenue Department at the above numbers for that information.###

## Portland-Area Students may apply for a Health Care Scholarship

**PORTLAND, Ore** – The Kaiser Permanente African American Association will award three \$500 college scholarships to high school seniors to study health care and one \$1,000 scholarship to a student currently enrolled in a health-related program at a two of four-year college or university.
