The suspect's M.O. is to target a business where a female clerk is usually working alone. The suspect claims to be armed and displays either a handgun or a knife.

The suspect is described as a white male, late 20's to early 30's, 6'00" tall, medium to stocky build with a slight belly, light brown to sandy blood hair worn above the ears on the sides and collar length in back, and one or two days growth of beard.

# **100 Complaints Filed With The Department Of Justice Resolved**

Attorney General Hardy Myers announced that an Oregon used car dealership with outlets in Salem and Milwaukie and its five owners have agreed to substantially change the company's method of operation and resolve more than 100 complaints filed with the Department of Justice. Entering into an Assurance of Voluntary Compliance, which admits no law violation, are Rytel Wholesale, Inc. and partners Tomothy D. Rytel of Durham, Richard R. Jones of Milwaukie, Rodney Thomas of Oregon City, Peter Mullane of West Linn and William Francis of Milwaukie.

"This comprehensive settlement not only addresses the past misconduct by Rytel, it establishes an appropriate dispute resolution mechanism for future disputes between the dealer and its customers," Myers said. "the allegations of misrepresentations made by Rytel's employees in the sale of used vehicles has been a continuing problem. The misleading activity will stop with this agreement."

Department investigators found that Rytel employees lied about the quality of the cars sold, failed to inform consumers of known material defects and did not comply with the terms in extended service contracts. A variety of other problems also were discovered.

Vancouver, WA – "We are well prepared for these new listings, and we've been expecting them," said Clark County Commissioner Betty Sue Morris. "Clark County takes our fish recovery effort very seriously, whether it" one species or several."

On Tuesday, March 16, the federal government declared chum and coho salmon as threatened under the Endangered Species Act. As with steelhead and bull trout, which were previously designated as threatened under ESA, these listings will affect Clark County.

The county is already putting considerable effort toward fish recovery. Among them are a program to construct fish ladders and enhance fish passages, a shift of additional resources toward promoting and enforcing erosion control, and the acquisition and restoration of high priority habitat.

Throughout county government, departments are assessing current practices, projects, and policies to ensure that they are "fish-friendly."

"We're looking at our own practices across the spectrum of county government," said Morris. "And not just the big things." She pointed to changes such as the way the county's Public Department now controls vegetation along rural roads, limiting chemical spray applications and instead using mechanical methods such as mowing and brushcutting. A reflection of the seriousness with which the county approaches ESA issues is the Board of County Commissioners' adoption of a \$1.67 million ESA budget for the 1999-2000 biennium. In addition, the commissioners have appointed an 18member citizen's task force to work with Clark County in addressing ESA issues.

The full impact of the fish listing will not be known for several months, until the National Marine Fisheries Service releases detailed rules outlining what activities are prohibited. "Regardless, the county hasn't been waiting for the details before taking action," said Morris. "We're moving forward in our efforts ro recover our fish right now." THE WEATHERMAN SAID NOT TO GO OUT
