CRIME STOPPERS HOMICIDE


Portland Police Bureau Detectives, in cooperation with Crime Stoppers, are asking for your help in solving the homicide of a young man who died trying to help protect a friend.

On Saturday, February 6, 1999, at approximately 1:53 in the morning, at a fast food restaurant at SE 49th and Powell, 19year-old Hien Minh Pham and two friends were in their car waiting in line. Directly behind them, alone in his vehicle, was another friend of Pham's.

The two cars were still waiting in line when another vehicle, described as a black or dark blue, late model Honda 2-door, pulled onto the lot and stopped. Numerous Asian males, who were in the Honda, got out and immediately confronted Pham's friend who was alone in his vehicle.

Pham got out of his car attempted to go to the aid of his friend. But it was there that Pham was stabbed and mortally wounded. According to investigators, the suspects, who confronted Pham's friend and stabbed Pham, are possibly associated with

a gang called "The Red Cobras." Crime Stoppers is offering a cash reward of up to \$1,000 for information, reported to Crime Stoppers, which leads to an arrest in this case, or any unsolved felony crime, and you need not give your name. Call Crime Stoppers at (503) 823-HELP.

to the head. James Keller was transported to Emanuel hospital where he later died of his injuries.

The investigation revealed that two of the Keller's children, a 16year old daughter and an 8-year old son, were inside the residence where the shooting occurred. A teenager, who was a family friend, was also present. Apparently James and Diana Keller were involved in a verbal argument prior to the shooting. They then went into the bedroom where James Keller shot Diana Keller with a handgun and then shot himself.

Crime Witness Program Expands Across the West

Under an agreement signed by the Bonneville Power Administration (BPA) and the Bureau of Reclamation (BOR), the two agencies will jointly run the Crime Witness Program. The \$100,000 agreement expands the program from its original base in the Pacific Northwest into all 17 Western states.

The crime Witness Program is a broad neighborhood-watch crime prevention program intended to combat crime, reduce vandalism, increase power system reliability; control costs and keep rates low. BPA Administrator Judi Johansen stated: "We are very pleased with this alliance between our two agencies. It is a natural fit. Leveraging each agency's resource in this constructive partnership is good for BPA, the BOR, our customers, the power system and the greater public interest."

The Crime Witness Program offers cash rewards of up to \$1,000 for information leading to the arrest and conviction of persons committing crimes against BPA or BOR facilities, property or personnel. Signs posted at facilities direct informants to call toll free 1-800-437-2744 to report criminal activities in complete confidence.

BPA orginally created its Crime Witness Program in 1994 to ask the public to help fight crime on its facilities. Before the program, crime directed against BPA personnel, property and assets cost the agency more than \$1 million each year. Since 1994, the program generated hundreds of telephone tips resulting in dozens of arrests, thousands of dollars in recovered property savings of more than a third since institution of the

Officers Discover Another Meth Lab In S.E. Portland

 Knock and Talk Leads to Working Lab in Bathroom

Acting upon a tip, Multnomah County Sheriff's Deputies discovered a working methamphetamine lab in a small apartment complex at 7606 S.E. Flavel. The lab was found at apartment #3. The officers made contact with the people living in the apartment and found a working meth lab in the bathroom.

Officers contacted Gresham HazMat Team 3 and the Special Investigations Unit (SIU) of the Sheriff's Office. They processed the scene and removed chemicals and part of a working lab. The area has been posted as unfit for habitation because it is a hazardous drug site.

Micah Taylor Nordstrom, date of birth 5/6/80, was taken into custody. He has been charged with possession, distribution and manufacturing of a controlled substance. He has a previous criminal record for possession of a controlled substance. Denise Marie Snyder, age 22, was also living in the apartment with her four year old child. She has not been charged with any crime.

During 1998, the Multnomah County Sheriff's Office investigated 18 meth labs. Our count for 1999, including this incident, is 11 meth labs. According to Sergeant Lane Sawyer, manager of the Special Investigations Unit, "Methamphetamine is our fastest growing threat. Local operations are clearly on the increase in Oregon. Meth is the number one drug of choice in Multnomah County.'

Vancouver Honored for a Decade of Commitment to Community Forestry

VANCOUVER-For a benchmark tenth year in a row, Vancouver has been named a Tree City USA by the national Arbor Day Foundation (NADF). Mayor Royce E. Pollard announced the designation as part of the Arbor Month proclamation at the Monday, April 5, City Council meeting. Mayor Pollard will formally accept the award from the State Commissioner of Public Lands, Jennifer Belcher at a State Arbor Day celebration Wednesday, April 14, on Officers Row.

To become a nationally recog-

nized Tree City USA, a community must meet four standards: a tree-care ordinance, a comprehensive community forestry program, and an Arbor Day observance. "Vancouver has a long history of commitment to its urban forests," observes Elizabeth Walker, city forester. We are proud that Vancouver is applauded for its ongoing efforts, and a decade of the national designation is noteworthy."

Tree City USA awards are presented by the NADF in cooperation with the National Association of State Foresters and the United States Forest Service. Clark County Underscores Local issues in Response to Bureau of Indian affairs

On Thursday, April 8, 1999 Clark County provided the Federal Bureau of Indian Affairs Office in Portland, Oregon, with its response regarding a proposal to put 170.8 acres of land in the

Ridgefield area into trust status. Inaddition to providing specific technical data requested by the Bureau of Indian Affairs, the county also responded to the BIA's requested for information about local concerns.

Chief among the concerns cited by the county was maintaining the integrity of Clark County's comprehensive Landuse plan. County citizens as part of an extensive four-year public process developed the land-use plan. "Our land-use plan helps ensure that

our decisions are consistent with the direction our citizens want the county to go and that they treat people equitably," said Judie Stanton, chair of the board of Clark County commissioners. "In responding to the Bureau of Indian Affairs proposal, weareunderscoring Clark County's need to fulfill our commitment to our residents and to the state of Washington to manage our growth."

The Shoalwater Bay Indian Tribe owns the land under discussion. Putting it in rust would take it off the property tax rolls and would allow it to be exempt from local zoning, building code regulations, as well as the payment of impact fees. Current zoning for most of the property in question is for 10-to 20-acre
