Eastman Parkway, Gresham, Oregon 97030, until 2:00 p.m., May 13, 1999 local time, at which time they will be opened, for the construction of a soccer field at Pat Pfeifer Park, Project No. 7076.

The work to be performed consists of, but is not limited to the construction of a soccer field. The major work items are as follows:

The contractor is required to pay a fee to the Bureau of Labor and Industries pursuant to the provisions of ORS 279.352 (2) and section 5 (1), ch 594, 1996 Oregon Laws. This fee is one-tenth of one percent of the price of this contract, but not less than \$100 nor more than \$5,000, regardless of the contract price.

All proposals must be submitted on the regular forms furnished by the City of Gresham, addressed and mailed or delivered to the Department of Environmental Services, City of Gresham, in a sealed envelope plainly marked, "SEALED BID for Pat Pfeifer Soccer Field - C.I.P. Project No. 7076," bearing the name and address of the bidder. Each must be accompanied by a certified check, cashier's check or bid bond in an amount not less than ten percent (10%) of the total bid. A performance and payment corporate surety bond in the full amount of the contract shall be required to guarantee faithful performance of the terms of the contract at the time of contract execution. In determining the lowest responsible bidder, the public contracting agency shall, for the purpose of awarding the contract, add a percent increase on the bid of a nonresident bidder equal to the percent, if any, of the preference

given to that bidder in the state in which the bidder resides. Each bid must contain a statement as to whether the bidder is a resident

bidder, as defined in ORS 279.029. Each bid must contain a statement by the bidder that the provisions of ORS 279.350 will be complied with.
