Senior Auto Accident Scam

Portland Police Bureau Elder Crimes Detectives, in cooperation with Crime Stoppers, are asking for your help in locating and apprehending a women who is targeting elderly motorist in a phony auto accident scam. Since February, of this year, eight cases have been reported in Portland. In all cases, the victims have been females over seventy-five years of age.

The suspect's M.O. is to watch for a senior motorist leaving a grocery store, or other parking lot, and follow them home. The suspect then confronts the victim, claiming that the victim's car struck and damaged her car in the parking lot. The suspect intimidates the victim, claiming if she, the suspect, files an accident report, the victim will either lose her license,

her insurance will go up, or both. The suspect then offers to forget the matter if the victim will pay her for the damage, which she claims is anywhere from \$250 to \$500.

The suspect takes the victim's money and leaves, but usually returns within the same day and tells the victim that the damage is far greater than first thought. Once again intimidating the victim, the suspect says she needs anywhere from \$1,000 to \$10,000 more, to repair her car, or she will file a report.

The suspect, who uses a first name of "Wedda," is described as a white female, 35 to 40 years of age, 5'5 tall, and weighs approximately 155 to 160 pounds, with hair that is dyed "strawberry blond."

ASTORIA, OREGON — Accused Seaside Beach thrill killer Bradley Price is slated to take the witness stand in his own defense in his trial in Astoria today. Body Found In The Columbia River

At approximately 4:30 p.m. on May 24, 1999 a Coast Guard crew spotted what they thought was a body floating approximately 2-3 miles upriver from the I-5 Bridge on the Columbia River. The CoastGuard called the Multnomah County Sheriff's office and a patrol boat was dispatched to the area. River Patrol Deputies recovered the body of a Caucasian adult male.

Sheriff's deputies believe the body is that of 39 year old Hans Oesch. Mr. Oesch crashed into the Columbia River in a light plane on January 8th, 1999 along with his passenger Kimberley E. Kelley. Ms. Kelley's body was recently recovered in the Columbia River. Deputies found Mr. Oesch's

One little girl said she woke up to find him standing alongside her bed. He also has left pornography in some of the homes he entered. None of the girls have been injured.



Clark County & Neighbors To Kick-Off Speed Reduction Campaign

The Clark County Public Works Department is working with neighbors to try to get motorists to slow down voluntarily in neighborhoods.

County officials are handing out "It's ourneighborhood...Slow Down!" lawn signs to residents living in the unincorporated areas of Clark County (outside of city boundaries), as part of an overall effort to make drivers aware of the dangers and consequences of speeding.

"The county is focusing its campaign on making drivers more aware of the dangers and consequences of speeding, and encouraging motorists to drive more safely," said Pete Capell, Clark County Engineer. "We receive numerous complaints about speeding vehicles inneighborhoods. This campaign is one of our strategies to help reduce speeds on residential streets."

Citizens living in the unincorporated areas of Clark County are encouraged to pick up a free lawn sign with the "It's our neighborhood...Slow Down!" slogan, and place it in their lawns that face the road. The distribution of the 1,250 signs will take place on Saturday, May 22 at the Clark County Public Works Operations Center, 4700 NE 78th Street, Vancouver, from 9 a.m. to noon. (Or, as long as supplies last)

In addition to the lawn signs, the county is installing larger, permanent versions of the signs onto all Clark County Neighborhood Associations signs. The "It's our neighborhood... Slow Down!" metal signs will be placed underneath the neighborhood signs that mark each entrance of the 35 neighborhood associations in the county. "The permanent signs will be a friendly, year-round reminder to motorists that speeding reduces the livability of our neighborhoods," said Holly Gaya, Clark County Neighborhood Outreach Coordinator.

The campaign kicks offjust as school is preparing to let out for the summer months, and a lot of kids will be playing throughout the neighborhoods.

"We have photo radar, and a multitude of traffic calming devices that we could use, but the person with the control is the person behind the wheel," said James Naramore, Clark County Sheriff's Deputy. "Our goal is to raise each driver's awareness, and let them know that they can make a difference in the quality of people's lives. It can also mean the difference between life and death."

The "It's our neighborhood... Slow Down!" campaign is being kicked off during National Public Works Week, May 17-22. The program was initially started by Clackamas County, Oregon, and was a huge success. Clark County is now partnering with them for the production of the lawn signs in order to reduce the individual unit cost.

City To Hold Public Hearing On Property Sale

A public hearing is scheduled Monday, June 7, before the Vancouver City Council for the purpose of approving a Purchase and Sale Agreement between the City and the Clark College Foundation. The Agreement provides that the City would convey approximately 4.8 acres of property south of Fourth Plain Boulevard and west of Fort Vancouver Way within the City's Central Park District.

The property was acquired by the City from the federal government in 1974 and is undeveloped, except for a pathway connecting Fort Vancouver Way with Fourth Plain Boulevard. In exchange for receiving title to the property, the Clark College Foundation has agreed to improve pedestrian access, provide lighting and utilize the property in conformity with the Clark College Master Plan and the Central Park Master Plan.
