# **Airport MAX Takes Off!**

#### Local agencies & Bechtel celebrate innovative project

ocal government agencies and Bechtel Enterprises Inc. celebrated their innovative public/private ven ture that will bring light rail to the Portland International Airport (PDX) in 2001 and development of 120-acres of commer-

cial real estate at the entrance to the airport. The Port of Portland, Tri-Met, the City of Portland, the Portland Development

Commission and Bechtel have joined together to form a unique public/private venture. It's the first of its kind in the

nation to use public and private funds to build light rail in connection with developing a high-density, transit-oriented project on airport property.

US Dept. of Transportation Deputy Secretary, Mort Downey, also attended the festivities and toured the 5.5-mile light rail extension, which is now under construction. Downey congratulated the Portland area for "being a national model of how to creatively build light rail lines in a highly competitive funding arena."

Downey added that the US Dept. of Transportation and the Federal Transit Administration helped with technical support for the Environmental Assessment for the Airport MAX project, and helped the Federal Aviation Administration in its approval to use existing passenger Facility Charges to pay for the Port's share of the light rail extension.


#### Airport Max project

The \$125 million project extends from the Gateway Transit Center, along I-205 to the PDX terminal's south baggage claim area. Major construction of the project began in June after the financing plan was finalized.

The partners are sharing the cost of the \$125 million project - no federal funds, state general funds or additional property taxes are being utilized.

Tri-Met General Manager Fred Hansen added that, "having private funds help pay for the light rail extension means we're able to expand our system and deliver more quality transit service to this growing region. This project, along with the development, also provides another example of how light rail serves as a catalyst to shape development and create livable communities."


