
FRAUD


Here's what you can expect:

Groundbreaking Set For Wildwood Park

Vancouver-Clark Parks and Recreation Services invites local residents to attend a groundbreaking ceremony Wednesday, July 21, at 4 p.m. for Wildwood Neighborhood Park, east of SE 134th Avenue and north of SE 27th Street. It will be the fourth of 19 parks to be designed and built as part of the Parks Legacy Project.

The neighborhood park will include play structures, swings, balance beam, spring riders, enhanced entry with accessibility ramps, bench, drinking foundation and new lawn. In addition, a total of 1400 linear feet of trail will be paved during the second phase of park construction.

Completion of the park will be

celebrated with a dedication ceremony in November.

The Parks Legacy Program will develop 19 neighborhood parks by the end of the year 2000, and three community parks by 2002. Construction is made possible by funding from the Real Estate Excise Tax (REET), implemented in 1996 with support from the Greater Vancouver Chamber of Commerce, Clark County Board of Realtors and Clark County Home Builders Association. All funds from this tax are designated for the development of parks.

Since the NSF program started in June 1998, 77 defendants have successfully completed the workshop, 317 bad checks have been cleared, and \$13,209 returned to merchants. Also, a total of \$18,797 in fees have been collected and returned to the county's general fund to offset the cost of running the program.

Mayor Appoints Assistant Chief Interim Chief Of Police

Timeline Set for Police Chief Recruitment/Hiring

Lauding her attributes for honesty, openness, and commitment to community policing, Mayor Vera Katz named Assistant Chief Lynnae Berg Interim Chief of Police to take over the bureau July 31, 1999, following Chief Charles Moose's departure.

"Chief Berg has a high level of integrity, complemented by her strong sense of personal responsibility, "said Katz. "she will be an active chief who will continue to move the bureau forward during the months of her tenure."

Berg joined the Portland Police Bureau in 1981, starting as a uniform officer in Northeast Precinct, including having spent time in the Mounted Patrol Unit and as a peer counselor and instructor for both defensive and patrol tactics. She made Detective in 1986, was promoted to Lieutenant in 1992, became a Captain in 1995, and was appointed Assistant Chiefin 1997.

"I have asked her to continue our

recruitment and hiring efforts, continue working on implementing the Institute of Law and Justice recommendations for the bureau, work to bring the labor negotiations to closure, and continue our efforts to reduce youth gun crimes," said Katz. "I am confident she will perform admirably and that she will make a positive impact during her tenure.'

Berg participates in the Regional Drug Initiative, has been a SMART volunteer at King School for three years, and is the treasurer of a nonprofit preschool. She is also a member of the International Association of Chiefs of Police and the National Center for Women in Policing.

She earned a Bachelor of Arts in psychology and Criminal Justice from Gustavus Adolphus College in St. Peter, MN in 1980 and received her Masters Degree in Public Administration from Lewis & Clark College in 1995.

Katz also announced that the National Recruitment Firm of Shannon Assoc., with Police Executive Research Forum, and the local firm of Kathleen Dotten and Associates, will lead the city's recruitment efforts for the permanent Chief of Police.

The Mayor's Office is currently in the middle of ten community focus groups slated through this week to hone a list of candidate qualities and skills desired for the Chief's position which will be used in recruiting materials. Previously, Katz's office received over 70 responses to a question posed in her website's "Pulse Poll" asking what citizens wanted from their next police chief.

Recruitment is expected to open in early August for approximately 30 days. By September 30, she hopes to determine semi-finalists and set interview dates. Finalist interviews are slated to begin October 15, with the goal to name the Chiefat the end of the month.

Buffalo Solider To Hold Anniversary Celebration

The 9th and 10th (Horse) Cavalry Association of the Buffalo Soldiers will hold its 133rd anniversary reunion July 28-31 with events centered on Vancouver Barracks in Vancouver, Wash. The event celebrates the early presence of African-American soldiers in the Pacific Northwest with the theme "Down by the Riverside," commemorating Buffalo soldier history from the Mississippi to the Columbia rivers.

The reunion also marks the 150th anniversary of Vancouver Barracks & the 100th anniversary of the death of honored Buffalo Soldier, Sgt. Moses Williams, who is buried in the post cemetery.

The keynote speaker will be Olympic medallist Lt. Col. Willie Davenport of the U.S. Army and National Guard. Davenport competed in five Olympic Games, winning a gold medal in the 110-meter hurdles in Mexico City in 1968 and a bronze medal in the same event in Montreal in 1976. Davenport will address the reunion luncheon Sat-

urday, July 31. The original Buffalo soldiers were African-American men and women who served in the U.S. Army from 1866 to 1944. The selection of Vancouver as the site of this year's reunion acknowledges close historical and present-day ties between the Buffalo soldiers and the U.S. military presence at Vancouver Barracks.

"It is important that we maintain the history of the Buffalo soldiers and educate others about their contributions to this country," said Carl Flipper, president of the association. In 1866, an Act of Congress authorized the creation of six regiments of black troops, two of cavalry and four of infantry. These troops were called "Buffalo Soldiers" by the Plains Indians. To be associated with the spirit of Native Americans' sacred buffalo was a measure of respect, and the black troops adopted the name and carried it proudly.

For nearly 40 years, the 9th and 10th cavalry regiments served on the frontier from Montana to Texas, along the Rio Grand in New Mexico, Arizona, Colorado and Dakotas. They built forts and roads, strung telegraph lines, protected railroadcrews, escorted stage coaches and trains, protected settlers and cattle drives, and fought Cheyenne, Arapaho, Kiowa, Comanche and Apache warriors.

Before disbanding in 1944, the 9th and 10th were formed into the 4th Cavalry Brigade in 1941, commanded by Gen. Benjamin O. Davis Sr. the 9th and 10th Cavalry Association holds annual reunions throughout the Nation. Associate membership is extended to any person who has rendered outstanding service to the United States through military service or service to the community The following events are open to


