## **Proud Habitat Homeowner Colise Johnson Helps Herself Home**

Portland Habitat for Humanity and Women's Missionary Union Build a Home in a Week!

uring the week of July 12th-16th, Portland Habitat for Humanity and a host of other blitz-built a single-family home for Colise Johnson, a single mother who takes on the world with determination in spite of several disabilities. Colise, along members of the Women's Missionary Union from as far away as Alaska, Hawaii, Nevada and Tennessee, the "Vision" Youth Choir from Bothel, Washington, and staff and volunteers from Portland Habitat for Humanity were found last week on the corner of NE 86th Avenue and Brazee, building the entire house from the ground up.

Colise Johnson is a single mother of two. This year, she is celebrating her eleventh year of sobriety. She suffers from both epilepsy and cerebral palsy, and, with the help of advanced neurological technology, is able to live inde-

pendently and pursue her dreams, one of which is to own her own home. "I strive to be as independent as possible - being a Habitat for Humanity homeowner will allow me to get out of the subsidized housing system and begin earning equity for myself and my family. The motto for Habitat is 'we'll give you a hand up and not a hand out', and I am

## **Johnnie Cochran Challenges Nation's Top Black Cops** "Put Me Out Of Business!"

Johnnie attorney, Cochran, challenged nation's top Black law en forcement officials to put him out of the business of making millions of dollars in civil rights lawsuits based on police brutality and excessive use of force. Cochran made his remarks at the CEO Symposium Speakers Forum at the Annual Conference of the National Organization of Black Law Enforcement Executive (NOBLE) in Portland Oregon.

Cochran is making millions of dollars litigating cases of alleged police misconduct across the country. Some of Cochran's high profile cases include: the brutalization of Abner Louima inside a Brooklyn, New York police station; the shooting death of 19 year old Tyisha Miller in Riverside, California; and the fatal shooting of Junious Roberts during a traffic stop by a Montgomery County, Maryland police officer.

The NOBLE annual Training conference and Exhibition runs through July 28th in Portland. NOBLE is widely involved in the development of policies and training programs for law enforcement departments and officers, offering instruction in proper procedures and circumstances under which officers should display and discharge weapons.

Cochran, a long-time supporter of NOBLE, praised its membership, saying, "This is one of my favorite organizations because, as the conscience of law enforcement, what you do is so important. One of the toughest jobs in the country is being a Black police officer."

But noting how some New York officers ended up in court for helping cover-up the assault against his client, Abner Louima, Cochran also urged the group to do more to help, "change the culture of police departments so the bad police officers fear

the good ones, and not vice versa." Cochran's address to the group will be aired on C-Span in August. The forum was moderated by NOBLE Executive Director, Robert L. Stewart and past Executive Chief James Golden, Saginaw Police Department; Chief Charles Moose; Portland Bureau of Police; Chief William Finney, St. Paul Police Department; Steve Rosenbaum, U.S. Justice Department, Civil Rights Division; Superintendent LeRon Howland, Director Police Practices Project, American Civil Liberties Union; Dr. Hubert Williams, President Police Foundation; Chief Ronald Neubauer, President International Association of Chiefs of Police; Sylvester Daughtry, Jr., Commission of Accreditation of Law Enforcement Agencies.
