## Teen-age Driver Leaves Fatal Crash Site

SALEM, Ore. (AP) — After smashing his car into a maple tree, a 17-year-old left a dead 15-year-old passenger in the front seat and went home, police said.

After a neighbor discovered the

wreck at about 6 a.m. Saturday, emergency workers cut the body of Gregory Allen Rose out of the badly mangled Mazda.

Salem Police Lt. Dan Dietz said Rose probably died upon impact in the accident, which is believed to have occurred about 2 a.m.

Officers later found Ernesto Perez Jr. at home.

At the teen-ager's request, he

was taken to a Salem Hospital for observation, Dietz said. He was in fair condition Saturday afternoon.

The driver of the car, whose name was not released, has not been charged.

Police said the driver will undergo blood and urine tests for substance abuse.

Rose would have been a sophomore at McKay High in the fall.

## Sen. Hatfield Announces Life For A Life Act

### Hatfield and Chief Petitioners Unveil Tough Initiative Stressing Punishment, Restitution for Oregon's Most Serious Criminals

Former U.S. Senator Mark O. Hatfield announced the petition filing for the Life For A Life Act, a new and tough approach to criminal sentencing which stresses punishment and restitution.

The Life For A Life Act, which Hatfield is working to place on the November 2000 general election ballot, amends the Oregon constitution and requires that anyone convicted of aggravated murder in the state of Oregon receive a mandatory life sentence without the possibility of release or parole.

"The Life For A Life Act guarantees that those who take someone's life—people convicted of aggravated murder—pay for their crime by spending the rest of their life in jail, with no chance of ever getting out again. It also

makes the criminal work, and all their earnings from prison work must be used to pay part of the cost of their incarceration and as restitution to the family of their victim," said Hatfield, one of the chief petitioners of the Life For A Life Act. "This measure also abolishes capital punishment in Oregon, and I am honored to be its sponsor, because this measure requires a life sentence for a life taken."

Hatfield is joined by former

Oregon Superintendent of Public Education Norma Paulus and OHSU physician William E. Connor, who all serve as the initiative's chief petitioners. At the press conference, Hatfield introduced Michele Kohler, a local attorney and co-founder of SAFES, a crime victims right groups. "My father was murdered nineteen years ago, and I will spend the rest of my life missing him. That's why I am a strong advocate for the Life For A Life Act—because I want the man who took my father from me to spend the rest of his life in prison. And I want him to spend the rest of his life paying us back for the cost of him being in jail. That's real justice," said Kohler.

Hatfield also read a statement from Tom Potter, a former Portland Chief of Police, that quoted Potter as saying, "I have to admit I have struggled over this issue for many years. As a police officer I have seen innocent murder victims and felt so much rage that I wanted the murderers to be sentenced to the same fate...my biggest concern was that a cold-blooded murderer would walk free and perhaps to harm others."

"The Life For A Life Act is the

first measure I could support. This tough, bold measure abolishes capital punishment in Oregon, and it ensures that the most hardened criminals—aggravated murderers—will spend their lives behind bars—with no chance of parole—ever," continued Potter.

Hatfield announced that his fellow chief petitioner, Dr. William Connor, will file the Life For A Life Act petition later at the Secretary of State's offices in Salem.

The Life For A Life Act is supported by a broad coalition of elected officials, religious leaders, members of the law enforcement community, and crime victims groups.

The Life For A Life Act does the following:

- Requires a Mandatory life sentence, without the possibility of release or parole, for all persons convicted of aggravated murder
- Repeals the "life with a minimum sentence" provision
- Requires that the convicted party work while in prison, and all earnings from prison work be used to pay for a portion of the cost of their incarceration or as restitution to the family of their victim
- Abolishes capital punishment

## Barone Convictions Upheld

(SALEM) - The Oregon Supreme Court has upheld the murder convictions and death sentences of a man convicted of sexu-

ally assaulting and killing three women in 1992. Cesar Barone was sentenced to death for the murders of Chantee Woodman and Marga-

ret Schmidt. Barone still faces charges in another state. He faces prosecution in Florida for killing a retired school teacher there.
