# **Community Notification** of a Sex Offender

The Portland police bureau is notifying the community of a Registered Sex Offender living in the Portland area. Ors.181.588 allows law enforcement agencies to release such information to the public regarding convicted offenders, who are required to register, when such information will increase public awareness and promote community safety.

The Sex Offender has been convicted of a sex offense that requires he register with a law enforcement agency in Oregon. His criminal history places him in a category, which indicates he may reoffend. The police does not want this subject at this time.

The Offender has served his sen-

tence and is no longer begin supervised by the Oregon Department of Corrections. The purpose of this community notification is to reduce the chance of further victimization by this offender as well as to promote community awareness and child safety. Intimidating, harassing, or threatening of this registered offender will not be tolerated and may be a crime.

Degree Aggravated Theft. According to investigators, the Bohanans collected money for a concert they said would be a fund raising benefit for a children's hospital in Portland. The fundraiser was found to be nothing more than a scam, and in fact, the Bohanans had never ever been in contact with the hospital.

The Bohanans have family and relatives living in the Portland metropolitan area, and Suzanne is believed to have been in the Minneapolis, Minnesota area in April of this year.

### **September Primary Will Be Mail-Only Ballot**

County Auditor Greg Kimsey earlier proposed a vote-by-mail primary to the political jurisdictions involved in this odd year election. Now that sufficient support had been given the decision has made to conduct the September 14th Primary election by mail ballot. Twenty-four of the jurisdictions including the City of Vancouver, City of Camas, City of Washougal, City of Battle Ground, City of Ridgefield, City of La Center, City of Woodland, Town of Yacolt, Clark County, Camas School District, Evergreen School District, Ridgefield School District, Green Mountain School District, Vancouver Port District, Camas-Washougal Port District, Hazel Dell Sewer District, and Fire Protection District Nos. 3,5,6,9,11,12,13 and 14 approved resolutions calling for the Primary to be conducted by mail ballot. With all of the cities, the Town of Yacolt and the Clark County Board of Commissioners giving their approval, this provided sufficient support to allow the County Auditor to make the decision to conduct the Primary by the mail ballot.

The purpose of this effort to conduct the Primary by mail ballot was made in response to the changing make-up of county voters. Almost forty percent of registered voters are now permanent absentees voters and represent almost 90% of the folks who will vote in the upcoming Primary Kimsey believes the vote-by-mail primary will:

Increase voter turnout, which is traditionally low for primaries in odd years. Reduce election costs fifteen percent because mail ballots elections are less expensive to administer than standard polling place elections.

Kimsey planed to increase permanent absentee registration by including permanent absentee ballot request forms with the primary ballots. Kimsey emphasized that this mail-only primary is not a precedent for future elections but just a way to promote a higher voter turnout in this odd year.

Portland Copwatch, a civilian group promoting police accountability through citizen action, has encouraged supporters to contact Chief Moose and Mayor Vera Katz and complain about the letters of commendation given to four police officers involved in the incident resulted in the death of Richard "Dickie" Dow.

Apparently, several individuals who have contacted the Chief's office to get the names of the officers have been refused this information. If it is the city's intention to honor these officers, we can only wonder why their names are not being released. Officers were called to the scene in October when a school police officer felt threatened by Dow; they even turned away the help of a neighbor who offered to do CPR, so the police did not attempt to revive Dickie; the story later changed during the grand jury inquest, and on July 22, Moose honored the four anonymous officers for allegedly helping to save Dow's life. Since Dow died the morning after the incident, this is a dubious "This is a slap in the face not only to

Dow's family, but to the community as

spokesperson for Copwatch. "It is reminiscent of when George Bush pardoned several key Iran-Contra figures in December 1992 as he was leaving office, insisting all the while they had never done anything wrong."

Since Moose's last day on the job is July 28, there is not enough time to pull together demonstrations against police practices, like the one held October 24th last year shortly after Dow's death. We can only hope that the current interim Chief and her successor will not place more value on "saving face" for the Bureau than on healing community wounds.

## **Homeless to Get a Big** Roof in Vancouver

Homeless veterans will get a boost from both federal government and the Vancouver Housing Authority when a 124-room housing project is dedicated Aug. 11 on the grounds of the Portland VA Medical Center in Vancouver, Wash. Central Park Place, a new four-story apartment complex designed for the homeless and those who are at risk of becoming homeless, is a culmination of a two-year construction project driven by more than 40 humanitarian and government agencies. The \$6 million projects major partners are the U.S. Department of Veterans Affairs and the Vancouver Housing Authority.

Construction was made possible through an "Enhanced use lease" agreement between the federal government and the Vancouver housing Authority. The land is being leased through the Department of Veterans Affairs and the Vancouver housing Authority.

Construction was made possible through an "enhanced use lease" agreement between the federal government and the Vancouver Housing Authority. The land is being leased through the Department of Veterans Affairs, in exchange for an agreement that sets aside half of the apartments for veterans. During periods in which no veterans qualify for apartments, non-veterans can use unoccupied rooms. The dual nature of the building makes it the first of its kind in the nation.

Ollie Hinson, a 51-year old Army veteran who says he was homeless for 13 years in Oregon and Washington, will be in the building's night manager. Hinson, a Portland VA patient who once served as a helicopter door-gunner in Vietnam, says that finding a home has given him "a new chance at life."

Central Park Police offers cooking, dining and laundry facilities on each floor, in shared areas. There are also meeting rooms, a lounge and balcony space. The building is handicapped accessible. The space can be adapted for residents with disabilities. Rents will range between \$295 and \$385 permonth.

Elderly or disabled persons design thirty-five of the apartments for permanent residence. The building offers safe, affordable, transitional housing for single adults who are currently or potentially homeless. In addition to housing, residents will have a chance to get a job counseling social services and other support in helping them rebuild their lives. Central Park Place is a drug-and alcohol-free environment.

Nearly one in three homeless persons in the United States is a veteran, according to the U.S. Department of Health and Human Services.
