Bank Fraud



The Portland Police office of the Federal Bureau of Investigation, in cooperation with Crime Stoppers, is asking for your help in identifying and apprehending four individuals involved in a scheme, which has cost area banks thousands of dollars. According to the FBI, the individuals are using the identities of other people to obtain fictitious identification from the Oregon Department of Motor Vehicles. The identification is then used to open fraudulent bank accounts that are utilized to pass stolen and counterfeit checks. These individuals, and others, have defrauded banks for over \$300,000. All suspects are described as white females in their

Homicide In Southeast **Portland**

On Tuesday, August 24, 1999, at approximately 2:55 AM, officers from Southeast Precinct responded to a call of a stabbing at 1408 SE Boise St. #9.
