OREGON STATE UNIVERSITY is seeking qualifications from architectural firms interested in providing design through construction phase services for the OSU Dixon Recreation Center Addition. Oregon State University (OSU) is preparing to renovate approximately 5,000 square feet and add 40,000 square feet to the existing student recreation facility on the OSU Campus. The new space will accommodate 3 basketball courts, and elevated running track, an additional 7,000 - 8,000 square feet for fitness classes, a new climbing wall and an outdoor recreational equipment rental area. The existing building will be renovated to accommodate ADA access at the west entrance, relocate administrative offices, expand the weight room and accommodate circulation connections to the addition.

The qualification responses will be used to develop a "short list" of three to five firms who will be invited to prepare proposals and participate in an interview.

Each must be accompanied by a certified check, cashier's check or bid bond in an amount not less than ten percent (10%) of the total bid.

Each bid must contain a statement as to whether the bidder is a resident bidder, as defined in ORS 279.029. This project is not subject to the license requirements of ORS 468A.720.

No bid will be received or considered by the City of Gresham unless the bid contains a statement by the bidder as a part of the bid that the provisions of ORS 279.350 and the Oregon Prevailing Wage Law will be complied with. No bid shall be received or considered by the City of Gresham unless the bidder is registered with the Oregon Construction Contractors Board.

You are hereby notified that you may appear on December 6, 1999, at 8:30 a.m., or as soon as counsel can be heard in Courtroom 47 of this court at 800 South Victoria Avenue, Ventura, California.

**You Are Further Advised as follows:**  
At the hearing, the Court must choose and implement one of the following permanent plans for the child: adoption, guardianship, or long-term foster care. Parental rights may be terminated at this hearing.  
On the Human Services Agency will recommend termination of parental rights. You are entitled to be present at the hearing with your attorney. If you cannot afford an attorney, you are entitled to have the Court appoint counsel for you. A thirty-day continuance may be granted if necessary for counsel to prepare the case.

At all termination proceedings, the Court shall consider the wishes of the child and shall act in the best interest of the child.

Any order of the Court permanently terminating parental rights under this section shall be conclusive and binding upon the minor person, upon the parent or parents, and upon all other persons who have been served with citation by publication or otherwise. After making such an order, the Court shall have no power to set aside, change, or modify it, but this shall not be construed to limit the rights to appeal the order.

If the Court, by order or judgment, declares the child free from the custody and control of both parents, or one parent if the other no longer has custody and control, the Court shall, at the same time, order the child referred to the licensed County adoption agency for adoptive placement by that agency.

The rights and procedures described above are set forth in detail in the California Welfare and Institutions Code Section 366.26. You are referred to that section for further particulars.
