Tri-Met received federal approval in September 1992 to design and construct the Westside rail project from downtown Portland to S.W. 185th Avenue in Washington County. In December 1994, the Federal Transit Administration approved an amendment to extend the rail line from S.W. 185th Avenue into downtown Hillsboro by Autumn, 1998.

Fiscal year 2000 funding requested in this grant application is for the final installment of the rail project, up to \$14,061,930 in federal assistance. (Exact amount depends on Congressional action.) These federal funds would be matched with up to \$7,029,910 in local dollars for a total project budget of up to \$21,091,840.

Project expenditures would replenish Tri-Met funds used to support civil construction including procurement of vehicles, track, electrification, signals, communication and fare collection equipment, and other system requirements; right of way acquisition; and project administration.

A discussion of displacement of persons, families and businesses associated with the Westside-Hillsboro Project is included in Final Environmental Impact Statements on file at Tri-Met offices. The project is in conformance with comprehensive land use and transportation planning in the area and is programmed in regional and State Transportation Improvement Programs.

You Are Further Advised as follows:

At the hearing, the Court must choose and implement one of the following permanent plans for the child: adoption, guardianship, or long-term foster care. Parental rights may be terminated at this hearing.

On, the Human Services Agency will recommend termination of parental rights. You are entitled to be present at the hearing with your attorney. If you cannot afford an attorney, you are entitled to have the Court appoint counsel for you. A thirty-day continuance may be granted if necessary for counsel to prepare the case

At all termination proceedings, the Court shall consider the wishes of the child and shall act in the best interest of the child.

Any order of the Court permanently terminating parental rights under this section shall be conclusive and binding upon the minor person, upon the parent or parents, and upon all other persons who have been served with citation by publication or otherwise. After making such an order, the Court shall have no power to set aside, change, or modify it, but this shall not be construed to limit the rights to appeal the order.

If the Court, by order or judgment, declares the child free from the custody and control of both parents, or one parent if the other no longer has custody and control, the Court shall, at the same time, order the child referred to the licensed County adoption agency for adoptive placement by that agency.
