It will guarantee full financing for outstanding students of color who come from poor families. Undergraduate students will be able to study any subject, but graduate students must be committed to studying science, math, engineering, computer technology, education and library science. By itself it will nearly double the number of scholarships

available and was called "earthshattering, landscape-changing" by William Gray, the head of the UNCF.

Mr. Gates himself noted that people of color are vastly under-represented in science, higher education and in his own computer industry. These scholarships, of which 1,000 are expected to be available every year, are designed to rectify those numbers.

Bill and Melinda Gates Foundation had made large contributions to education, health and library sciences. It has assisted in wiring the county's public libraries for the Internet and has made some \$200 million in contributions to research and distribution of vaccines for AIDS, Malaria and other diseases. Reporters Use Tabloid Tactic To Mislead Voters

As a candidate for an elective position, there's an expectation for a measure of fairness from the press. In my recent run for commissioner for the Hazel Dell Sewer District (HDSD) in Vancouver, I received none from the Columbian.

Two Columbian reporters took on the role of candidate hit squad as they attempted to ridicule me and mislead voters by sensationalizing my private disputes over property taxes and past problems with my sewer. They withheld from readers (voters) important information, made quotes from words I never said, and selectively used facts to distort the full truth.

As a public relations professional, I've been quoted in the Wall Street Journal, Los Angeles Times, and Denver Post to mention a few newspapers. For the first time in my 20 years talking with the press, two reporters actually altered my words and the facts to create front-page news.

I chose to run for the position of sewer commissioner because I have experience working with organizations to improve their image and efficiency. As I heard people complain about the sewer district, I took into account my own experience of poor service, and decided I could make changes. My work with Portland's highly effective wastewater management group gave me an inside track to information to accomplish this goal.

Columbian reporter Erik Robinson told me that my desire to serve ratepayers was not an interesting story. It would be better if I "was angry at the sewer district" and out to get someone fired. He wanted to write this story even though I said it was false.

In the two articles written by Robinson, there was much misinformation. For example, I told him my PTA Board shared with me their sewer complaints. Robinson wanted to write: "PTA urges Hall to run." Not true and I told him to change it. He retaliated by printing Hall 'backs away from PTA involvement' and 'now says the conversation never

took place.

In criticizing me for my dispute with the sewer district, Robinson suspiciously withheld the fact that the sewer district refused to answer my numerous complaints about the backflow of sewage into my home for more than four years. He kept secret from voters why it took them so long to respond.

When I complained the source of the misinformation was a HDSD employee, in a phone conversation, reporter Gregg Herrington got angry that I reported the involvement to the State Public Disclosure Commission. He retaliated with a sensationalized story on my property tax dispute with Clark County, a dispute I made public weeks earlier. The newspaper used a large headline as if I had committed a terrible crime.

Herrington to chose to withhold key information. When I personally presented him with important facts from my attorney and the State Board of Equalization prior to the release of his story, he openly ignored them. "I'm asked my attorney's name, I gave it, but added, "I could not remember how to spell it." In his article, he wrote: Hall "couldn't remember his attorney's name."

As the only minority to run for office in Clark County this election season and the first African-American in more than 10 years, I was told to expect the Columbian to focus their "special attention" on me and to scrutinize my every deed.

I disregarded this advice after an editorial noted my being the most "energetic" candidate in the race. However, when I met with several members of the Columbian's editorial board, I was forced to recognize the disrespect as one editor opened and read his mail while I talked. I knew then that it would be foolish to expect any fairness and objectivity from them.

After the election, reporter Robinson tried several times to reach me. I issued a written statement. It was the only way I believe I could avoid being misquoted again. But even then I had serious doubts.


I tell my closest friends about the situation and they become disgusted at the thought of anyone misusing or cheating anyone, especially when they are representing an organization, The Oregonian.
