Metro Council Approves Convention Center Deal

Memorandum of Understanding with Partners Means Completion of OCC

An affirmative vote by the Metro Council today will help protect our region's economy into the 21st century. The Council approved a Memorandum of Understanding with the City of Portland, Multnomah County, the Tri-County Lodging Association, the car rental industry, the Portland Oregon Visitors Association, the Portland Development Commission and Tri-Met. The MOU outlines a financing strategy that will provide the \$105 million needed to complete Phase II of the Oregon Convention

This is something we have been working toward for months," said Metro council Presiding Officer Rod Monroe. "We know how important this project is to our regional economy in terms of the jobs it will create, the business it will generate and the tourists it will motivate to visit our area. By completing Phase II, we will be able to keep the Convention Center competitive in today's market without any increase in property taxes."

Metro owns the Oregon Convention Center and operates it through the Metropolitan Exposition-Recreation Commission. Right now, the Oregon Convention Center generates about \$370 million in economic benefits for this region each year. The completed OCC is expected to generate an additional each year as well as 2,500 new jobs

Secretary of State Phil Keisling Announces Resignation

Portland - Phil Keisling announced today his resignation as Oregon's Secretary of State. Keisling, who has served as the state's second highest elected official for almost nine years longer than all but three other Secretaries in Oregon history plans to step down on November 8, 1999.

"After long and careful deliberation, I've decided to leave office now rather than when my term expires in January, 2001," Keisling said. "Doing this will provide real, meaningful time as a private citizen to seek new challenges and gain fresh perspectives on life and on Oregon."

"In addition, speculation about my future political plans has led me to believe that my early departure will better ensure the Secretary of State's office can continue to sustain and enhance the high reputation it has earned for fairness, integrity, and efficiency in fulfilling its many important duties."

"Words cannot convey my appreciation for the chance to work with the Secretary of State's 200 dedicated employees, Oregon's 36 outstanding county clerks and their staffs." Keisling said. "Together, we've had the privilege to work in partnership with the citizens of this exceptional state, and I'm enormously proud of what we've accomplished."

As the state's chief elections officer, Keisling crafted Oregon's 1991 legislative redistricting plan and led efforts to increase voter registration and participation through such innovations as "Motor Voter" registration and Vote-

As auditor of public accounts, Keisling worked to expand auditing of government programs and to transform the auditing function to focus on the effectiveness and performance of programs. Secretary Keisling also played a major role in improving management of state owned lands and the Common School Fund as a member of the State Land Board.

Under Keisling's leadership, his agency has delivered better, faster and less expensive services to Oregonians. An example of this is the Corporation Division, which reduced staff by 31 percent since 1991, and which will soon offer on-line registration to Oregon's 100,000 businesses at substantially reduced fees.

"We've accomplished almost all of our key agenda items," Keisling said. "Campaign finance reform is the glaring exception and something that I will actively support as a private citizen and former state official."

When asked about his future career plans, Keisling said that he will explore opportunities in the private sector that will increase his understanding of Oregon's new economy. "I'm making this announcement with no job lined up," he said. "As many Oregonians have done, I'm working on a resume."

"It's never easy to leave a job one truly loves, but I'm convinced this will make me a better citizen, a better manager, and a better leader," Keisling said. "And should I have an opportunity to serve again in elected office, I believe this kind of experience will make me a more effective public servant."
