

Tom Landry dies at 75 Lewis free on \$1 million bond after two weeks in jail

Tom Landry, the Dallas Cowboys coach who led America's Team to five Super Bowls and was famous for pacing the sidelines for three decades wearing a stone face, business suit and felt hat, died Saturday, Feb. 12, 2000. He was 75.

From Tom Landry Elementary School in a Dallas suburb to Tom Landry Stadium in his South Texas hometown, the former Cowboys coach received many lasting tributes during his life.

His death has fans clamoring for more.

Since Landry died Saturday of leukemia, the buzz around the area has been about making some grand public gesture to honor his memory.

The most popular, symbolic ideas include changing the name of Texas Stadium to Landry Stadium and-or attaching Landry's name to part of Central Expressway, a state highway that runs through the heart of Dallas. Although Cowboys owner Jerry Jones owns the lease to Texas Stadium, the building itself is owned by the city of Irving. The city council had taken no action as of Tuesday and the Cowboys were keeping quiet about their plans. We are still in the process of formulating plans to honor coach Landry," team spokesman Rich Dalrymple said. "They will be announced at a later time." Central is the part of state highway 75 that runs north-south through Dallas along the east side of downtown. The team's original headquarters faced the highway, so Landry used to drive it to work nearly every day. The name could be changed at the city level or state level. Whoever makes the change would have to pay for it.

Surrounded by deputies, a smiling Ray Lewis left jail on \$1 million bond Tuesday, slipped into a car and rode away with his lawyers, mother and fiancee.

"Thank God to be out!" said the Baltimore Ravens' linebacker, who was wearing a brown football jersey with the word "Supreme" on the back. Lewis is free for the first time since

Jan. 31, when he was charged with murdering two men after a Super Bowl party earlier that day. His lawyer, Ed Garland, said Lewis

felt sympathy for the families of the two men who were killed and looked forward to clearing his name.

Lewis' mother sat in the back seat, a copy of "The Inspirational Study Bible" on her lap. Lewis' fiancee sat with two young boys on her lap beside his mother.

Lewis will spend time with his family in Atlanta and then return home to Baltimore Wednesday, Garland said. The release on bond was "step one" for Lewis, Garland said.

"The next step is to get him acquitted," he said. "I never expect him to set foot in a jail again, unless it's to do charitable work."

About 90 minutes before Lewis left the jail, another defendant, Reginald Oakley, arrived with his lawyer to

surrender.

A third suspect, Joseph Sweeting, surrendered Monday.

Lewis, 24, and his two companions are charged with murder in the stabbing deaths of two men during a brawl outside an Atlanta nightclub. Lewis, Sweeting, 34, of Miami, and Oakley, 31, of Baltimore, were indicted Friday in the deaths of Richard Lollar, 24, and Jacinth Baker, 21, who were stabbed during the 4 a.m. fight.

West powers past East in All-Star game

Kwan wins fourth U.S. title in shaky manner

CLEVELAND (AP) - Instead of one Tara Lipinski to push Michelle Kwan, there were two. And push they did. But Sasha Cohen and Sarah Hughes simply didn't have the clout with the judges to pull off what Lipinski did in the 1998 Olympics.

"I don't think I would have won ... because Michelle is a world and Olympic skater and very well known," Cohen said. "She has a reputation which I don't have."

That reputation might have saved Kwan.

Skating cautiously and with little fire, never connecting with the audience, Kwan still won her third straight U.S. Figure Skating Championships crown Saturday night.

She should thank some generous judges for helping her stave off the wave of young Americans.

"I really feel I have to up the ante,"

said Kwan, who wore her hair back Saturday night "to look younger.

"It's, I think, my seventh nationals and I feel ancient next to these people."

While the four-time champion skated tentatively and fell once in the free skate, her main competition - 15-yearold Cohen and 14-year-old Hughes also had falls. But their performances weren't as uninspired as Kwan's. They simply don't have the resumes quite yet. And Kwan, the Olympic silver medalist who has won more U.S. championships than the likes of Kristi Yamaguchi, Rosalynn Sumners and Dorothy Hamill, certainly does. "I knew I wanted to go out and feel good about myself after the program," said Kwan, 19, who also has won two world titles. "I didn't want any pity." Instead, she got charity, not only from the judges, eight of whom placed her first - Hughes got the other top spot - but from her competition.
