The character of the work is (general description). The major quantities involved are:

- Furnish and place 150 tons of rock rip rap for stream bank toe
- Furnish materials and install 600 linear feet of coir fabric lifts for bank
- reinforcement. Furnish and install 1800 native plantings.
- Dispose of surplus material at an acceptable-off-site location.

Provide erosion control.


