Safeway will meet with City Council on July 12 and a decision will be made regarding the license. Without a liquor license, Safeway could lose approximately 40 percent of its sales because often residents buy alcohol along with their groceries at the store. But Waterman said the remodeling and the liquor license issues are separate. He is adamant about the renovation taking place. "The growth of the area dictates a need for the store's expansion and it is what the community wants," he said. "Now is the right time."

Safeway's Portland division comprises 108 stores, 94 in Oregon and 14 in Southwest Washington. Safeway Inc. is one of the world's largest food and drug retailers, operating approximately 1,663 stores in the United States and Canada. Safeway's common stock is traded on the New York Stock Exchange under the symbol SWY.

A group of marketing consultants hired to help promote two Northeast Portland business district wants the community to help choose a theme and logo that identify the area that encompasses Northeast Martin Luther King Boulevard and Northeast Alberta Street.

The New Market Group will sponsor a name/logo contest that began this week and ends July 6. Colorful "ballot boxes" have been placed at Northeast Portland businesses. Community residents and business owners are to select one of three logos and one of four themes on a postcard-like ballot or write their own suggestion. Participants are to place their postcard in the sealed boxes.

The ballot boxes are located at several area businesses such as Geneva's Sheer Perfection, Reflections Coffee and Books, Doris' Café and Albina Community Bank.

The logo or theme that receives the most votes will represent the business districts and appear on materials such as brochures, banners, shopping bags and other items.

The postcard selections are the result of several community meetings in which business owners and community residents were asked to describe Northeast Portland. Many attendees described the area's cultural diversity and richness as one of the area's top attributes, said Faye Burch, the New Market Group's project manager.


"We believe that our logo designs and theme reflect what our community asked us to create," Burch said. "We want to reflect the eclectic and

growth.' Many Portland business districts have themes and logos that define them such as the Pearl and Hawthorne districts.

The Northeast business district boundaries along Martin Luther King are Lombard Street to the north and Broadway to the south. Northeast Alberta Street also is included in the district. That area is bounded by Northeast Martin Luther King Boulevard and Northeast 33rd Ave. Currently, the targeted area is comprised of two districts. But the theme and logo will encompass both,

The Portland Development
