## New Portland Police rules call for a shave and more

Portland police Chief Mark Kroeker has signed off on a stricter set of grooming standards for officers, but members of the Portland Police Bureau have until Aug. 1 to shave off their beards or shorten their sideburns.


Under a new general order, called "Appearance & Grooming," police cannot wear beards, or have sideburns that extend below their ears. Men's hair cannot extend over the tops of their ears or touch their shirt collars.

Women's hair may touch their collars but not extend past that. Neither male nor female officers can wear their hair braided or in a ponytail. Both men and women are prohibited from wearing earrings or a necklace that is visible. No pins, ribbons, stickers or other items are allowed to be placed on or over any part of the officer's badge, and only two authorized pins—such as a police union or D.A.R.E. pin — may be worn on the officer's right shirt pocket.

Detectives who are not in uniform are restricted from wearing shirts with logos Even before the new policy was written, many police supervisors shaved off their beards, trimmed their sideburns and removed their earrings. But some officers who do not support the chief's grooming policy have vowed not to adhere to the new restrictions. The new policy does not say what discipline,

if any, officers may face for not following the rules.

Tamara DeRidder has accepted the position of Long-Range Planning Manager with the City of Vancouver, She assumed her duties July 3. The selection process included panelists from a neighborhood association, the Vancouver Planning Commission, Planning Services team members, and Clark County staff.

DeRidder has 14 years of experience as a professional planner and holds a Masters degree in Urban Planning from Portland State University. She has worked in planning and leadership positions in the cities of Sandy and Oregon City and for other cities as a consultant with Cogan Owens Cogan Consulting. ### Hillsboro police seek link in recent church break-ins

A string of church break-ins over the weekend may have been done by the same group of vandals, police said.

Four churches in Tigard, three in Beaverton and three in unincorporated Washington county were ransacked between Friday night and Sunday

Nothing was stolen from most of the churches, although several computers were taken from Tigard-area churches. Damage estimates weren't known Monday.

The break-ins marked the second time in as many months that churches in Tigard and Beaverton were burglarized and vandalized. In mid-June, burglars broke into about six churches, some several times. In those incidents, burglars stole computer and electronic equipment and small amounts of cash, left graffiti and urine on office equipment and took a church van on a joyride.

Investigators did not know whether the burglaries and vandalism in June or last weekend were connected, said Sgt. Marlene Gaskins, spokeswoman for the Washington County sheriff's office.

The break-ins are not considered hate crimes, Gaskins said. Damage included overturned pews, whipped cream stuck on furniture, doors kicked down, computer monitors smashed with hammers and holes poked through a portrait of Christ.

#### Inmate injury under investigation

· East County Major Crime Team Investigates Inmate's Injuries

Multnomah County Sheriff's Office Detectives, Portland Police Bureau Detectives, and the East County Major Crimes Team, comprised of Detectives from the Gresham Police Department, Oregon State Police and the Multnomah County District Attorney's Office are investigating the circumstances leading to the hospitalization of an inmate, Jon R. Beckel, on Saturday, July 1.

Mr. Beckel was booked into Justice Center Jail at approximately 0330 hours on Saturday, July 1, by officers of the Portland Police Bureau on two warrants related to DUII charges. Mr.

Beckel was transported to the jail after being threatened at Good Samaritan Hospital for a laceration to his forehead. Mr. Beckel, uncooperative during the booking process, was restrained by deputies and was evaluated by Corrections Health nurse. He was visited several times by medical personnel while in custody. At approximately 1420 hours on Saturday, Mr. Beckel was transferred, by ambulance, to OHSU after experiencing an apparent seizure.

#### Injured woman removed from Sandy River

 Group Floating Sandy River Stranded After Tubing Mishap Sheriff's Deputies Corbett Fire Rescue 65, Gresham Fire Department and the 304the US Air Force Rescue

Squadron combined late Thursday, June, 9 to remove one party of four floaters from the Sandy River Canyon above Oxbow Park. The victim identified as Tracey Lamance of Boring was taken by helicopter to Mt. Hood Medical Center with injuries to her leg and knee.

The other three members of the rafting party hiked out of the canyon with Corbett Rescue 65 who reached the party at dusk and administered first aid.

The operation was coordinated by Gresham Fire and assisted by KGW Channel 8 helicopter.

River Patrol Deputies Eric Gustafson and Linda Cordes-Hadley remind all those recreating on the Sandy that is a wild river and should not be rafted using inner tubes or inexperienced rafters.

#### **Escort Owner Arrested** Again

On March 16, officers from the Portland Police Bureau's Drugs and Vice Division executed a search warrant and arrested 49 year-old Wai Chi Shirley Schubert at her residence in the Dunthorpe neighborhood. Schubert, better known in the escort business by the name "China," was arrested at the time for Promoting Prostitution, a class C felony.

According to investigators, Schubert was known to have operated escort services under at least 34 different business names in the Portland, Vancouver, and Salem Areas over the last 18-24 months. On Tuesday, June 27, at 7:57 p.m., Schubert was arrested for 3 new counts of Promoting Prostitution.
