This project is for a public work and is subject to ORS 279-348 to 279.380, the Oregon Prevailing Wage Law.

All proposals must be submitted on the forms furnished by the City of Gresham, mailed or delivered to the Department of Environmental Services, City of Gresham, in a sealed envelope plainly marked, "SEALED Bid for the 2000/2001 Crackseal, Project No. 502003, bearing the name and address of the bidder.
