

Interstate Avenue, Portland at 9:00 AM on Wednesday, August 9, 2000. The purpose of the hearing is to consider projects for which federal FY01 5309 Fixed Guideway Modernization and State Transportation Program (STP) funds from the Federal Transit Administration is being sought for Tri-Met's rail preventive maintenance program.
