The Polk County Housing Authority (PCHA) will receive bids for LaCreole High-Rise Roof until Tuesday, 3:00 p.m. on the 29th day of August 2000, at 204 SW Walnut, Dallas, Oregon 97338, at which time and place all bids will be made public.

The basic work includes: Remove and replace the existing roof at 345 Donald Street, Dallas, OR 97338 and install a three-ply asphalt membrane system with insulation and mineral surface cap sheet, under a "lump sum" contract.
