Crime Stoppers Case #00-31: Sexually Assaulting Portland Police Investigators, in cooperation with Crime Stoppers, are asking your help in identifying and apprehending the individual responsible for sexually assaulted a young woman. On Friday, April 21, at about 1 pm,

a 28-year-old woman was returning from a camping trip when she stopped at a restaurant located at Northeast 125 and Sandy Boulevard. While in the parking lot of the restaurant, the woman was sexually assaulted in her van. The suspect also took property belonging to the victim. The suspect is described as a black male, 23 to 27 years of age, 5'10" to 6'0" tall, with a slender build, and what was described as a young, "feminine" face. He was wearing a thigh length, green, army style jacket, a medium blue, long sleeve shirt with a hood, and jeans. Investigators

believe the suspect may frequent the area or live nearby. Crime Stoppers is offering a cash reward of up to \$1,000 for information, reported to Crime Stoppers that leads to an arrest in the case or any unsolved felony crime, and you need not give your name. Call Crime Stoppers at (503) 823-HELP.

Prostitution mission conducted by central precinct

On Friday, July 28, and Saturday, July 29, 2000, officers of Central Precinct conducted a prostitution mission targeting problem areas along W. Burnside / Park Avenue to 17th Avenue.

As a result, 28 males were arrested for Prostitution, one male for Possession of a Controlled Substance in Second Degree, and one male for Public Indecency (urinating in Public). There were 12 vehicles seized and towed during the mission, as well as 12 traffic citations issued.

The affected neighborhood associations, business owners and resident have encouraged these ongoing prostitution missions because they give warning to the "johns" that if they come into their neighborhoods looking for prostitutes they will be arrested. Repeat offenders will lose their vehicles permanently, based on the city's vehicle forfeiture ordinance.

Fatal traffic collision claims two lives SE 112th Avenue/SE Flavel Street

On Saturday, July 29, 2000, at 2:59 a.m., a fatal traffic collision occurred at SE 112th Avenue and SE Flavel Street, which claimed the lives of two people and injured three others.

A 1994 Ford F-150 pickup, driven by 35 year-old Constantine Nichlas Deleganes

Of14547 SE Megan Way in Clackamas, Oregon, was southbound on SE 112th Avenue when the collision occurred. The teenage driver of a 1992 Toyota Paseo was westbound on SE Flavel Street when she failed to stop at the stop sign at 112th Avenue and was stuck broadside on the passenger side. The front right teenage passenger died instantly and the driver died en route to Emanuel Hospital. The names of the deceased are being withheld pending notification of family. A third occupant of the Toyota, 19 Sher Xiong of SE Portland, is in critical condition at OHSU Hospital.

Constantine Nichlas Deleganes received minor injuries and was cited and released for Driving Under the Influence of Alcohol. A Multnomah County grand Jury will review the case for possible other charges. The passenger in Deleganes' vehicle, 35 year-old Lynette Sponsler, suffered a broken leg and remains at a OHSU Hospital.

Portland Police Bureau Homicide Detectives have been conducting an ongoing investigation into the death of 39 year-old Robert Leroy Gilbo, who was found in his car on Friday, July 14, 2000, at the intersection of Vancouver Avenue and N. Monroe Street. Information was developed which lead to the arrest of a suspect. On Thursday, July 27, 2000 at 11:00 p.m., the Washington County Sheriff's Office Tactical Negotiation Team took 31 year-old Timothy Alan Schubert into custody without incident. Schubert was apprehended in a parked motor home at a nursery located at 1793 NW Martin Road in Washington County. A handgun was found in the motor home after Schubert was taken into custody. Timothy Alan Schubert has been charged with one count of Aggravated Murder with a Firearm and one count of Robbery in the First

Degree with a Firearm. Schubert was booked into the Multnomah County Booking Facility and is being held without bail. Arraignment was held on Monday, July 31, 2000, at 2:00 p.m., at the Justice

Home Invasion Robbery Suspect Arrested

Atapproximately 7:30 pm, Friday, July 28 Aaron Michael Quigley, D.O.B. 6/ 7/82 was taken into custody be Multnomah County Major Crimes Team Detectives, Officers from the Portland Police Bureau and Deputies from the Clackamas County Sheriff's Office at a fast-food restaurant in North Portland. Acting on a tip, police established an intensive surveillance of locations Quigley was thought to

Quigley was wanted in connection with a home invasion robbery that took place in Fairview on July 17th. Four armed intruders, including this suspect broke into an apartment of the victim and attempted to rob him, two other adults and a child at gunpoint. The resident (victim) managed to get to a firearm of his own and fired at the suspects, chasing them from the apartment. Three of the four suspects were arrested on July

Quigley is lodged at the Justice Center Jail charged with five counts of Robbery I, five counts of Robbery II,

ten counts of Burglary I, two counts of Assault II and two counts of Kidnap II. Bail is expected to be high.

Arrest Made in Child Sex Abuse Case

On Tuesday, August 8, 2000, East Precinct Officer Jason Pearce responded to report of sex abuse to a child. An investigation revealed that three sisters, current ages 7,9, and 11 had been abused over two-year period by an individual identified as a boyfriend of the mother. Acting on information developed by Officer Pearce, the suspect, 30-year-old Michael L. Rouse, was located at a Southeast Portland restaurant and transported to East Precinct where he was later charged with rape in the First Degree and 7 counts of Sodomy in the First degree. Rouse was lodged at the Multnomah County Detention Center with bail set at 28-Million Dollars. A photograph of Rouse is available in the Portland Police Bureau identification Division on The 12th floor of the downtown Justice Center. Suspects In Sexual Assault Apprehended

On Wednesday, August 9, 2000, at about 2 a.m., North Precinct Officer Jason Sery while on routine patrol, noticed suspicious activity in an alley in the 6800 block of N. Oregonian, between N. Fessenden and N. Powers. The officer observed a female being held by one male as another male sexually assaulted her. As the officer drove closer, he heard the victim screaming.

When the officer shined his spotlight on the individuals, both males began running from the officer and then proceeded to get on bicycles to flee east on N. Powers. Officer Sery apprehended the suspects at the intersection of N. Oregonian and N. Columbia Way. The suspects are identified as 17-year-old Michael Levon Rhone and 17-year-old Matthew Charles Monhead. Both were arrested and charged with Rape in the First Degree and Sodomy in the First Degree. The suspects are lodged at the Multnomah County Juvenile Detention Facility and will be arraigned tomorrow. The victim, a 34year-old woman, was taken to OHSU.
