## Community Notificed of Sex Offenders Released from Prison

The Portland Police Bureau is notifying the community of two registered sex offenders living in the 200 block of Northeast Stanton Street.

Mark Steven Klemmer is a 39-year-old white male, 5'9", 165 pounds with blond hair and blue eyes.

Klemmer was convicted in 1993 for molesting a 12-yearold boy who he had befriended.

The second offender is Dean Gordon Alby, a 42-year-old white male, 5'6, 160 pounds with blond hair and blue eyes.

Alby was convicted of molesting a 13-year-old boy whom he met while working as a coun-

It's believed that there is a substantial risk that Klemmer and Alby could re-offend, police said. Oregon law allows enforcement agencies to release such information in order to promote community safety.

Both individuals are required to register with a law enforcement agency.

The two men are not wanted by the police at this time. They have served their sentence and

are no longer being supervised by the Oregon Department of Corrections. Intimidating, harassing or threatening these men will not be tolerated and may be a crime, police said.




#### Man on Loose After Fleeing Police



Portland Police Bureau Detectives, in cooperation with Crime Stoppers, are asking for your help in locating and apprehending Sean Joseph Cook.

Cook is charged with parole violation and escape. Police stopped the car Cook was driving on Dec. 28 at Southeast 21st and Belmont Street. When officers attempted to place him under arrest, he fled the scene. Cook may have suffered a gunshot injury during his escape, and may have sought medical treatment. He is described as a 26year-old Native American, 6'2" tall, weighing 220 pounds, with black hair and brown eyes. Cook may have friends in Eugene and family in the Burns area, police said.
