"I hope that in the coming months we will see their decision to address this issue as an authentic sign of compassion toward the thousands of people who each day encounter this form of racism and not another insincere exhibit of minority outreach aimed at the upcoming elections."

Bush's Own Words

The following is a text of the speech President George W.Bush gave last week to the Congress of the United States regarding racial profiling:

"As government promotes compassion, it also must promote justice. Too many of our citizens have cause to doubt our Nation's justice when the law points a finger of suspicion at groups, instead of individuals.

All our citizens are created equal

and must be treated equally. Earlier today I asked Attorney General Ashcroft to develop specific recommendations to end racial profiling. It is wrong and we must end it.

In so doing, we will not hinder the work of our Nation's brave police officers. They protect us every day, often at great risk. But by stopping the abuses of a few, we will add to the public confidence our police officers earn and deserve."

# Survivor Cruel to Animals

Last summer, "Survivor" producers were taken to task for allowing the game show's contestants to cruelly killrats, and chickens-and CBS was in hot water for broadcasting their antics. When Survivor II began shooting in the Australian outback, CBS officials made sure that the animal abuse continued in the network's shameless pursuit of ratings. Recently, viewers were stunned and sickened to watch as contestants stabbed a pig to death, then smeared her blood on his cheeks.

Australia's Animal Protection Act makes it illegal to torture, mistreat, or bait any animal or to instigate such acts

If Survivor producer Mark Burnett and CBS placed a tame pig on the scene, separated a wild pig from her family group, or baited or corralled the pig so she could be attacked, they are likely to have to have violated the criminal code. "Instigating" cruelty is an offense equal to stabbing an animal

CBS's relentless pursuit of ratings is as bloodthirsty as the Survivor contestant who was apparently chosen because he was willing to stab an animal to death in pursuit of money. While CBS is earning a reputation as the network of animal haters, growing numbers of former fans are turning off Survivor-and visiting PETA's Web site PETA-online.org for a free vegetarian starter kit. # Civil Rights Leader Dies

(AP) — Verdell Rutherford, a civil rights leader who fought to pass Oregon's 1953 civil rights law, died Feb.27. She was 88.

Rutherford was secretary of the Portland chapter of the NAACP from the late 1940s to 1962. Her husband, Otto Rutherford, was the chapter's president for two terms in the 1950s. Together, the couple worked closely with former U.S. Sen. Mark Hatfield to pass civil rights legislation that had failed in 17 previous legislative sessions.

The 1953 law the Rutherfords fought for outlawed discrimination in hotels, motels, restaurants and recreational facilities on the basis of race, religion or national origin.

"There should be a school named for them, institutionalizing their contribution to our state," said Sen. Avel Gordly, D-Portland. "Every school student should learn about the life and times of Verdell and Otto Rutherford. Their work really uplifted the humanity of all of us." Verdell Rutherford used the office equipment of Dr. DeNorval Unthank to do volunteer NAACP work and as a result, Dr. Unthank hired her as a medical secretary. She worked for him for nearly 20 years.

She was the first secretary of the newly rebuilt Bethel A.M.E. Church from 1959 to 1962. She was a member of the N.E.Y.M.C.A. Board, the P.T.A., the Urban League, and the Oregon Association of Colored Women's Clubs. She received the woman of

the Year Award from the Oregon Association of Club Women, an affiliate of the National Association of Colored Women's Clubs, in 1958. She was a member of the Culture Club, a social and civic club, for more than three decades, serving in many offices.

Rutherford's greatest interest was her collection of newspaper articles and magazines that chronicled the story of people of African descent. She considered herself a local historian. Parts of her collection have been displayed, among other places, at national NAACP conferences, annual meetings of A.M.E. Churches, and at various programs for Black History Month throughout the years.

Rutherford was born Verdell Burdine in Wainwright, Okla. Her family moved to Bend shortly after her birth and lived in Marshfield, now Coos Bay, for seven years before moving to Yakima, Wash.

She married Otto Rutherford in 1936. He died in August. Rutherford is survived by a daughter, a son, two sisters, six grandchildren and 11 great-grandchildren. Another son died in 1974.

A memorial was held on Saturday in Portland. Internment is in Tahoma Cemetery in Yakima, Wash.
