Robber Puts on Apron and Goes to Work

Portland Police Bureau robbery detectives, in cooperation with Crime Stoppers, are asking for your help in identifying and apprehending the suspect in an armed robbery. On Saturday, Feb 10, at about 8:40 in the evening, an armed gunman entered the Plaid Pantry at 14090 N.E. Sandy Blvd.

After robbing the clerk, the suspect placed her in a back room. Before leaving, he put on a Plaid Pantry apron and for the next 25 minutes waited on customers while posing as a store employee.

The suspect is described as a white male, 18 to 23 years of age, 5' 8" tall, weighing 160 pounds with brown hair. He was wearing a black Columbia zip-up fleece jacket, baggy blue jeans and was wearing a silver chain with a ring on it. He was armed with a small

Man Wanted for Armed Robbery

The Washington County Sheriff's Office, in cooperation with Crime Stoppers, is asking for your help in locating and apprehending Alonzo H. Nolan Jr.

Felony arrest warrants are on file charging Nolan with armed residential robbery and distribution of a controlled substance.

He should be considered armed and dangerous.

Nolan is described as a 21-

year-old black male, 5'11" tall, weighing 165 pounds, with black hair and brown eyes. Nolan is known to go by the nickname of "Smokey".

This Week in History

March 28, 1979, America's worst commercial nuclear accident occurred inside the Unit Two reactor at the Three Mile Island plant near Middletown, Pa.

March 29, 1973, the last United

States troops left South Vietnam, ending America's direct military involvement in the Vietnam War.

March 30, 1981, President Reagan was shot and seriously injured outside a Washington, D.C., hotel by John W. Hinckley Jr. Also wounded were White House news secretary James Brady, a Secret

Service agent and a District of Columbia police officer.

March 31, 1968, President Johnson stunned the country by announcing he would not run for another term of office.

April 1, 1945, American forces invaded Okinawa during World War II.

Man Sentenced For Polluting Willamette

An Oregon City man has been sentenced in U.S. District Court in Portland to three years of probation and six months of home detention for dumping pollutants into the Willamette River over a five year period at the former Smurfit Newsprint Corp. plant (now Blue Heron) in Oregon City.

Gary Field worked as environmental services superintendent for Smurfit. He admitted his involvement in falsifying water discharge reports between 1994 and 1999.

The Oregon Department of Environmental Quality levied a \$96,280 fine against Smurfit in June 2000 for falsification of wastewater discharge re-

ports and failure to properly monitor discharges in violation of the federal Clean Water Act.

Field pled guilty to one felony count of discharging pollutants at his Feb. 8 sentencing hearing before the U.S. District Court in Portland.

Field left Smurfit last year.
