County Will Investigate **Hospital Shooting**

Multnomah County mental health officials said they will conduct a separate investigation of the fatal shooting of a Mexican man during a confrontation with police at Gateway Pacific Hospital, a Portland psychiatric facility.

Officials want "to see if there was neglect," said Janice Gratton, manager of the Behavioral Health Division for Multnomah County.

Portland police are conducting their own internal investigation into the shooting of 29year-old Jose Santos Victor Mejia Poot of Yucatan.

Mejia Poot's' family and the

Mexican consul in Portland have questioned whether it was necessary to kill Mejia.

Concern has grown among Hispanic leaders over the shooting after it was learned that Mejia Poot had been taken to the psychiatric hospital by police while reportedly suffering an epileptic seizure aboard a city bus.

"If there's evidence that there's fault of either the hospital or the (police) bureau, we have to strongly look at litigation," said Carlos Rivera, a prominent Hispanic activist and member of the Hispanic advisory council to the Portland Police Bureau.

The police investigation must determine whether deadly force was appropriate, and whether a language barrier had anything to do with the shooting, Rivera said.

Pedro Mejia Zumarraga, father of the dead man said he visited his son at the hospital the day before the shooting to take him his epilepsy medicine, but no one there understood him. Mejia Zumarraga, who speaks no English, said he met no one at the hospital who spoke Spanish or Maya, the native language spoken by the family.

This unknown individual and others have defrauded banks of over \$200,000.

The suspect is described as a black female, 5' 5" tall, weighing 240 pounds with black hair and brown eyes. She has used

Couple Found Dead in Eastgate Lot

Police in Portland are investigating the shooting death of a couple found dead in their car outside a movie theater.

The man and woman were found with multiple gunshot

wounds just after midnight Sunday at the Eastgate Theater in Southeast Portland.

Police spokesman Henry Groepper says a security guard found the couple and called 911. The vehicle's engine was still running.

The victims were identified as Ramona L. McGee and Jerry James Spencer. Both were 34 years old.

Beer Lures Pig on Loose to Captivity

A pot-bellied pig's penchant for beer was her ultimate downfall.

Multnomah County Animal Control officers stalked the black-andwhite animal using ropes, cages and dog food as bait after golfers spotted the 22-pound pig grazing on the Rose City Golf Course. But it took a saucer of beer before the pig succumbed.

The beer sedated the pig enough that animal control officers were able to pick her up. The pig, now called "Rose," is waiting for a new owner at animal control's headquarters.

She loves dog biscuits and can stand on her hind feet on command.

Multnomah County allows pot-bellied pigs as pets unless they weigh more than 70 pounds.

Vandalized Glass Turns Into Art

Tri-Met has figured out what to do with all those bus stop glass panels that get vandalized every year. It's sandblasting them into glass art. Officials call the program "an innovative solution to an expensive problem." Tri-met says vandals scratch and deface about 750 glass panels a year. Each one costs about 250 dollars. The public agency's solution is to pull the vandalized panels down, sandblast the scratched parts into artist-designed motifs, and reinstall them. The program is expected to save Tri-Met at least 100 thousand dollars a year. Tri-Met is now testing a leaf pattern by Seattle artist Carolyn Law, which will eventually be used in more than 100 panels. The agency plans to request proposals from artists for additional designs this summer.


Oregon Teen Appears in Court on NY Internet Threat

WHITE PLAINS, N.Y. (AP) — An Stoppers, which leads to an arrest Oregon teen-ager who allegedly made a threat that shut down several Westchester County schools last month was released on his own recognizance last week but is forbidden to use the Internet. Benjamin Ballard, 18, of Portland, appeared in federal court in White Plains before U.S. Magistrate Judge Lisa Margaret Smith on a charge of transmitting an interstate threat via the Internet. A pretrial hearing was set for May 9. Until then, Smith ordered Ballard to stay off the Internet, leave his house only to go to

work and school, and surrender his passport. Ballard flew in from Oregon for the proceeding, accompanied by his father. The charge is a felony that carries a potential sentence of five years in prison upon conviction.

Officials canceled classes in the Edgemont school district on March 23 after a student received an Internet threat about "a lot of people dead" at Edgemont High School. The threat, which was not specific, was sent via an America Online chat room, and the student, who was not identified, notified police. Court papers allege that Ballard pretended to be a senior at Edgemont High School and warned the recipient not to go to school the next day because "there's going to be alotofpeople dead tomorrow, but hey we get to be on the news.

The FBI, called in by Greenburgh police and the office of Westchester District Attorney Jeanine Pirro, traced the message to Ballard's home and seized his computer. The prosecution was turned over to federal authorities because the threat was apparently made from out of
