

Metro is soliciting bids for the construction of a CEMENT/BENTONITE SLURRY TRENCH

CUTOFF WALL on the St Johns Landfill located at 9363 North Columbia Boulevard in Portland Oregon. Sealed Bids must be delivered to Metro, Regional Environmental Management Department, 600 NE Grand Avenue, Portland, Oregon 97232 no later than 11:00 a.m. (postmarks not accepted), Thursday, May 24, 2001. All contractors must complete and submit the supplied form in a separate envelope listing all first tier subcontractors, within four (4) hours of bid closing (or before 3:00 p.m.), to the same location. At that time, the Bids will be opened and publicly read aloud in Conference Room 270 located in the Metro Center also at 600 N.E. Grand Avenue.

The work contemplated consists of the installation of a cement/ bentonite slurry trench cutoff wall located in the north perimeter road of the St. Johns landfill. The wall will be 2 1/2 feet wide, approximately 1,025 feet in length and varies between 12 feet and 30 feet in depth. Significant slurry design and quality assurance is required.

A tour of the site will be conducted immediately following this meeting.
