



Interview Describes Mother's Killing Spree

The mother who allegedly drowned her five children one by one in a bathtub told police the oldest one tried to escape but she chased him through the house, the Houston Chronicle reported Friday.

In the videotaped interview with police, Andrea Yates described how she methodically killed the children June 20, the newspaper said. It quoted an unidentified police investigator as saying she spoke in a "zombie-like



Device Detonated at I-5 Rest Stop

An apparent illegal firework found taped underneath a freeway rest area picnic table was detonated Thursday by a bomb squad.


The device, found at the Interstate 5 rest area north of Vancouver was about the size of a beer can, State Trooper Greg Little said. There was a cigarette

taped to the fuse, but it was unlit or went out.

A motorist spotted the device shortly before noon at the Gee Creek rest area. It

was reported to a state Transportation Department employee who called police.

The rest area was closed while a bomb squad from Portland responded and detonated the device. The area then reopened.
