Briefly, the work consists of approximately 4,600 sq ft renovation of existing lab spaces including demolition, salvage of existing casework to Owner, installation of new and relocated casework, new lab top, reagent shelving, sinks, cupsinks, gas, air, walls, door, ceilings, lights, plumbing, electrical hardware and new finishes. The Klamath Hall renovation is approximately 3,120 sq ft on the second floor. The Willamette Hall renovation is approximately 1,480 sq ft on the third floor.
