Nudist Acts by Woman Found Legally Questionable

(AP) — Terri Sue Webb discovered there's no such thing as blind justice.

Webb, 26, was sentenced for contempt of court Thursday and released after she appeared in Deschutes County Circuit Court in Bend last Wednesday stark naked.

Webb, who was on trial for riding her bicycle in the buff last summer, wore only a pair of red cowboy boots before Judge Barbara Haslinger.

In the hushed courtroom, Deputy District Attorney Ruben Munoz could be heard saying: "I had a feeling this might happen."

Haslinger gave Webb a chance to dress, then ordered deputies to arrest her for contempt of court.

Webb was sentenced Thursday to a year of supervised probation and ordered to get a mental health exam.



Haslinger said Webb must attend all future court dates fully clothed. If Webb does not comply, she could be sentenced to 29 days in jail, Haslinger said.

Webb was arrested in July and charged with disorderly conduct for pedaling around downtown Bend in the nude.

Alana Brenneman, her attorney, said that charge is without merit because Webb did not cause any inconvenience, annoyance or

alarm. Moses Williams, a friend of Webb's, said Webb was fighting the charge because non-sexual public nudity is not against the law.

"She has the right to express herself," he said. "Nudity is not disorderly conduct."

A new trial date was set for Jan. 27.

At the time his body was found, Larry Dean Begay Sr., who was 5'8" tall, and weighed 150 pounds, with black hair and brown eyes, was wearing dark blue jeans and a black jacket.

Portland House Fire Leaves Two Dead

(AP) -A house fire located at 7006 NE. Roselawn on Thursday left 25-year old Samantha Davis and 33-year old Hans Jensen dead and two others seriously injured. Jack Finders of the city Fire

Bureau said the man and a woman

who died in the fire were living in

the basement - unable to get out of

the burning house.

Finders said neighbors spotted the flames shortly after midnight, reported the fire and helped two men get out of the house. Those two men are listed in serious condition with smoke inhalation at Legacy Emanuel Hospital, and at least one is also being treated for burns. Finders said no firefighters were injured.

The fire started at the rear of the house, but Finders said it remains unclear whether it started on the inside or outside. The cause remains under investigation and there was no immediate estimate of damages.

Man Critically Wounded from Gun Shooting in Vancouver

On Nov. 4 at about 0216 hours, Vancouver Police Officers were dispatched to investigate a shots fired call in the 300 block of East Mill Plain.

Upon their arrival, 27-year old Jose Saucedo Cordero, of Hillsboro, was found to be suffering from a single gunshot wound to the neck. He was transported by ambulance to the Emanuel Hospital in Portland and is in critical condition. It is expected that the victim will survive his injuries.

Initial investigation revealed the shooting took place as the victim was driving his vehicle east bound in the 200 block of Mill Plain.

At least four shots were fired at the victim's vehicle. A male passenger with the victim is unharmed.

Interviews with the passenger and others in the area indicated the shots may have been fired from a black, full size pickup truck last seen east bound on Mill Plain. No further suspect information is available.

At the present time, no motive for the shooting has been discovered.

The case is being investigated by members of the Vancouver Police Violent Crimes Unit.

Shooting Victims Found

(AP) — A southeast Portland man apparently beat his wife in an attempt to kill her before shooting and killing himself, police said.

After receiving an incomplete 9-1-LcallOct. 29 from Cherie Lynn Blake, 46, police found her in her home with critical head injuries, the result of blunt-force trauma, police said. Richard Ray Blake, 54, was found dead of an apparent self-inflicted gunshot wound.

The couple had been separated since 1999 but continued to live next door to each other and see each other socially.

Detectives determined that the injury and death were a domestic violence-related attempted murder and suicide, said Sgt. Brian Schmautz, a Portland police spokesman.
