

Masked Gunmen Enter Vancouver Residence

Vancouver Police Officers responded to a residential burglary and assault Nov. 17 in the Fisher's Mill area.

Two males wearing ski masks entered the residence through an unlocked back door and surprised a young female in her bedroom. One of the two suspects was armed with a handgun. The subjects grabbed the victim, threatened her, and attempted to bind her.

When she became agitated, they ran out the door.

A police canine unit and major crime team responded to assist in the investigation. Fingerprints were subsequently recovered from the scene. No suspects have been identified.

Guilty Pleas Heard in Portland Policeman Stabbing

(AP) - A 24-year-old man accused of stabbing an off-duty Portland police officer at a downtown restaurant has pleaded guilty to several assault-related charges.

Under a plea bargain, Domanick Campbell of Portland was sentenced to about six years in prison. He also faces three years' probation.

Prior to Campbell's Nov. 19 plea, co-defendant Tyrone Anthony Thurman, 23, pleaded guilty to third-degree assault. Thurman was sentenced to two years in a work-release program, eight weeks to a forest work project and five years' probation.

Police identified Campbell and Thurman as two of seven men who assaulted Officers Chad Gradwahl and David Michaelson on May 26 as the off-duty policemen were leaving the restaurant.

Gradwahl was knocked to the ground unconscious. Michaelson was stabbed in the lower back near his rib cage and struck in the head with a beer can. Both officers were treated at a local hospital and released. Police said the assailants were members of the Crips gang. They described the assault

as unprovoked and probably in retaliation for contact one of the suspects had with an officer two nights earlier.

Two other defendants, Ronald Lamont Cunningham, 22, and Anthony Thomas had already pleaded guilty to third-degree assault, and were each sentenced to two years of work-release and five years' probation.

Two other defendants in the case, Dante Lamont Porter, 25, and Damon Cunningham, 25, are scheduled to go to trial Dec. 21. A seventh defendant, Jerrin Lavazie Hickman, 23, is still being sought.

Family Offers Reward in Disappearance





Mail Centers Test Negative for Anthrax

(AP) - Oregon's central mail processing and distribution centers have tested negative for anthrax, the U.S. Postal Service said.

Authorities never suspected that anthrax spores would be found at the downtown center and a small airport facility used for out-of-state mail. The processing centers were among 260 post office buildings across the country tested.

"We are very pleased to hear the results," USPS District Manager Dallas Keck said in a statement. "We want to ensure the safety of our employees and customers and conducting these tests is part of doing that."

Man Sentenced to Five Years

(AP) - A man who stole a patrol car in Vancouver and led deputies on a 30-minute chase has been sentenced to five years in prison.

Superior Court Judge James Rulli on Monday handed down the longest sentence possible to James Clyde Shields.

In July, Shields was arrested for possessing methamphetamine and driving with a suspended license. He was released on bail and told to appear in court Aug. 2. He didn't, and a felony warrant was issued for his arrest.

Collision Results in Manslaughter

(AP) - A 45-year-old man is charged with manslaughter in connection with a traffic accident that killed a Gresham woman.

Mary Margaret Ewing, 44, died Nov. 19 when her car was struck in an intersection on Southeast Stark.

Gresham police say Ewing was northbound in the left turn lane on a green light when an eastbound car struck her. The collision propelled her car into two others.

The driver of the eastbound vehicle, Joe Dudley Hughes, suffered critical injuries in the wreck. The drivers of the other two cars had minor injuries.

Hughes is under guard on charges of manslaughter, driving under the influence of intoxicants and for violating felony D-U-I-I probation.
