Eastern Oregon University (EOU) is requesting proposals from qualified firms for construction materials testing and inspection services for the new Eastern Oregon University Science Center in La Grande, Oregon. The building consists of approximately 90,000 square feet on three floors with a partial basement area and a detached greenhouse and mechanical systems building of 3,360 square feet. In addition, approximately 31,300 square feet on three floors of the existing science building will be seismically upgraded and remodeled into offices and classrooms. Estimated construction cost is approximately \$24 M.

EOU will require inspection and testing services for poured in place concrete and its related steel reinforcement; precast architectural concrete; post-tensioned concrete; geotechnical/soils inspections and testing; masonry, masonry grout, and asphalt testing; both field and fabrication shop structural steel welding inspections and structural steel bolting requirements. The inspections will insure that all work is in compliance with the project drawings, specifications and all applicable building code and materials testing requirements. Proposers are directed to review project specification Sections 01400 and 01445.

The selected individual or firm shall have the capability of providing the complete requested services package. The selected consultant shall have the ability to maintain rapid construction schedules and work with the general contractor to maintain established schedules. The general contractor will notify the selected consultant of schedules with dates and times of required inspections. Inability to meet scheduled inspection dates and times will result in prompt dismissal.

A geotechnical soils investigation and site-specific seismic hazard analysis was performed in January 2001. Copies of this report are available on-line from Ford Graphics.

Proposals shall include but are not limited to a detailed description of the services to be provided under each phase of the contract and a listing of the required tests and inspections to be performed. Proposers are invited, but not required to provide a proposed cost for this contract work. However, such cost information will not be included in the evaluation of the proposals.

Proposals received will be evaluated based on the following criteria:

- 1. Experience:** The experience of the proposer in inspection and testing fields of: poured in place concrete and its related steel reinforcing; precast architectural concrete; post-tensioned concrete; geotechnical/soils inspections and testing; masonry, masonry grout and asphalt testing; both field and fabrication shop welding inspections and structural steel bolting requirements.
- 2. Capacity:** The capacity and capability of the proposer to perform the work, including all inspections and reports within the time limitations set forth.
- 3. References:** A thorough review of the listed references of the proposer's project experiences, which were similar in type, size, cost and complexity. A minimum of four such references must be furnished complete with names, addresses and phone numbers.
- 4. Availability:** The consultant's availability for the entire project and its familiarity with the area in which the project is located, including knowledge of design and construction techniques either peculiar to or typical of the area.
- 5. Experience of On-Site Employees:** A thorough review of the employees to be permanently assigned to this project and their experience and qualifications in the related appropriate fields of testing required by the project, including experience on projects similar in type, size, cost and complexity.
- 6. Cost Management:** A review of cost management techniques the consultant proposes to use in completing the work.
- 7. Communication:** Factors demonstrating the ability of the consultant to communicate effectively with project personnel, including contractors, architects and other design professionals and owners representatives.

EOU Construction Manager and Director of Facilities and Planning will constitute a consultant screening committee, which will evaluate and rank proposals meeting the requirements of this RFP. The decision of the committee will be final. Once proposals have been ranked, the committee will initiate negotiations with the highest ranked proposer for the purpose of arriving at a mutually satisfactory contract.

At its sole discretion, EOU reserves the right to reject any or all bids. This RFP does not obligate EOU to pay any costs incurred by any proposer in the preparation or submission of any response to this request.
