## Pope Summons Cardinals Over Scandals

(AP) — Pope John Paul II has summoned American cardinals to Rome to talk about sex scandals in the U.S. church, the Vatican said Monday.

The summons comes just days after the top U.S. bishops were in Rome for semiannual talks with the pontiff. The sex abuse scandals dominated the discussions.

Bishop Wilton Gregory, president of the U.S. Conference of Catholic Bishops, said the pope wants to help.

"He extended his hand in support to the bishops of the United States," Gregory said Saturday. "The Holy See has demonstrated an extraordinary openness in understanding the particular situation that we face in the United States."

The Roman Catholic Church in the United States and elsewhere is under fire for its handling of a series of allegations of sex abuse by priests.

The church is accused of covering up misconduct by priests, in some cases by moving known abusers from job to job. It has already paid millions in damages and faces numerous lawsuits from victims.

John Paul has spoken only briefly of the scandals and some critics have sharply faulted the Vatican for a lack of leadership in a time of deep crisis.



## Kaiser Offers Help on Child Safety Seats

"Over 85 percent of car safety seats are installed incorrectly," says Ruth Harshfield, executive director of the Child Safety Seat Resource Center, based in Gladstone. "These free safety seat checkup clinics can be extremely helpful to anyone who has young children riding in their automobile."

According to Oregon's Department of Transportation, booster seats and child safety seats save lives.

In 2000, 12 children up to 8-years-old died as a result of motor vehicle crashes in Oregon.

Of those who died, four were not in child safety seats or seat belts, and four were in seat belts only instead of booster seats that are now required.
