### GENERAL INSTRUCTIONS.

#### AUTHORITY OF AGENTS.

1. Agents and employés are positively prohibited from accepting or undertaking to execute in the name of the Company, and as a part of its business, and its risk, any order whatsoever for the purchase or sale or custody of Mining or other Stocks, unless specially authorized in writing. Persons desiring to transact such business can compunicate directly with any Wells, Farro & Co.'s
