- 1. Strategic planning contract: This contract for \$40,100 with Decisions, Decisions assists the City of Portland Bureau of Housing and Community Development (BHCD) with a community-based strategic planning process. Community Alliance of Tenants a North and Outer SE Portland project using code enforcement to address poor housing conditions (PS) (\$12,000). Education Action Team/Success By 6/United Way a North Portland kindergarten transition project (PS)(\$11,224). Growing Gardens improvements to the North Portland St. Johns Woods community garden (PF) (\$5,000). 




