



The Review Getting Away with Murder

Jury finds shooting was homicide

On the one-year anniversary of the police shooting death of Kendra James, the community is reacting to a second deadly force encounter with an unarmed black motorist that has yielded similar results.

A secret grand jury relieved officers of any criminal wrongdoing in the March 28 shooting death of James Jahar Perez, but a public inquest jury ruled Friday that the death was a homicide.

After James was fatally shot a was also cleared of criminal wrongdoing by a grand jury but never faced an inquest. He is back to work after a six-month suspension.

The purpose of the inquest set out by District Attorney Michael Schrunk was to relay facts to the public, but not to find fault with the officers or their actions; a process Senators Margaret Carter and Avel Gordly, both African Americans from northeast Portland, want to do something about.

Carter and Gordly are committed to making changes regarding grand juries and public inquest proceedings in the next legislative session.

"In the absence of a civilian rethe public inquest is the only tool we have to dissever the facts. To

that end, the inquest for the most part did what it was supposed to do," Gordly said.

She said the inquest should be used with every police use of deadly force and should have been utilized in reviewing James' death.

Gordly said she and Carter will work to open grand jury records to public review and consider how grand juries are conducted. Additionally, the senators will look into granting public inquest juries faultfinding power by giving them the option to return with a verdict of criminally negligent homicide.

"We need to make it so one of the findings (of the public inquest) can be criminally negligent homicide so its not left to the district attorney to limit the findings of an inquest jury,"

said Gordly. Under current law, an inquest jury is limited to answering only who the deceased person was, when and where the death occurred and the cause and manner of death. which cannot result in criminal or civil actions.

The officers involved with Perez's shooting still have to face their boss, Police Chief Derrick Foxworth, and a Use of Force Review Board, which is currently being assembled. An internal review of the police bureau and a civil rights investigation by the FBI are also underway.

The Use of Force Review Board is a new creation, resulting from policy changes following James' death. The panel will consist of two citizens, a liaison from the mayor's

Perez Family Addresses Inquest Jury

Faults mindset in police stops

The following statement to the inquest jury looking into the death of James Jahar Perez was made on behalf of the Perez

The Perez family appreciates the opportunity to thank the inquest jury for its role in allowing the tragic facts of Jahar Perez's death to be made public and the opportunity to make this brief statement.

It seems clear to the Perez family that Jahar's death was unnecessary. The particular issue before the inquest jury is "What was the cause of Jahar Perez's death?" The immediate answer, of course, is that he died from the gunshot wounds inflicted by Officer Sery.

But there are other questions of importance to the family and the community. Some of these questions are: (1) Why are Portland police officers making pretext stops of African Americans in Portland? (2) Since when are Portland officers expected to stop African American drivers simply because they think their car is "too nice" for the neighborhood? (3) Why wasn't less than lethal force used to arrest an unarmed man?

It seems obvious from the evidence that Officers MacComber and Sery had much more on their mind than making a simple traffic stop from the moment they saw Jahar Perez drive by. It was this mindset which caused Officer Sery to draw his weapon. It was this mindset which caused Officer Sery to shoot Mr. Perez who was unarmed and
