This contract provides for the improvements of approximately 3,400 feet of roadway including pedestrian traffic signal, illumination, retaining walls, asphalt and concrete pavements, sidewalks, curbs, drainage improvements, landscaping, underground utilities, roadway excavation, water and sewer, and associated work, all in accordance with the attached Contract Plans, these Contract Provisions, and the Standard Specifications.

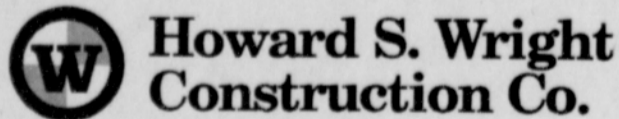
