No New Penalties in James Death Call 503-288-0033 ads@portlandob server.com Officers only rebuked for having dinner together

CHANGE LIVES (AP) - Portland Police Chief Derrick Foxworth rebuked two officers involved in the fatal shooting of Kendra James, saying they shouldn't have met for dinner before a grand jury convened. Other than that, however, an internal affairs investigation into seven post-shooting concerns will result in no punishments. The most serious allegation had been that officers failed to give James proper medical aid as she lay handcuffed in the street.

Funk Legend Remembered

Rick James hit the top with 'Super Freak'

(AP)—Funk legend Rick James, best known for the 1981 hit "Super Freak" died Friday. He was 56.

James died in his sleep at his residence near Universal City, apparently of natural causes, said his publicist, Sujata Murthy. James lived alone and was found dead by his personal assistant, who notified police, she said.

The exact cause was not immedi-

With long hair elaborately styled braids or Jheri curls. James was one of the biggest R&B stars of the replacement surgery.
