Notice of Comment Period and Public Hearing for Recommendations to Address Barriers to Fair Housing.

The Housing and Community Development Commission (HCDC) will accept public testimony on the Draft Recommendations developed to address fair housing barriers identified in the draft Analysis of Impediments to Fair Housing Report (AI). The public hearing will be held at the Multnomah County Building, 501 SE Hawthorne, Third Floor, Room 315, on Wednesday, December 7, 2005 at 6:45 p.m.

The draft AI describes barriers to fair housing and housing choice in Multnomah County, including discrimination encountered in financing, renting or buying a home based on race, color, religion, national origin, gender, disability, sexual orientation, source of income and/or the presence of children in the household (family status). The Recommendations will be added to the AI following public comment, and will guide how public funds are spent to prevent and address unlawful discrimination, and how public policy can be used to advance housing choice.

Metro is soliciting bids for removal of the existing well pump and replacement with a new line shaft vertical turbine pump and motor, variable frequency drive in a new panel, a new pump control panel, a new magnetic type flow meter, miscellaneous piping replacement and upgrading, upgrading of the sodium hypochlorite feed system, and upgrading of the pump power supply system. Sealed Bids must be delivered to Metro, Regional Parks and Greenspaces Department, 600 N.E. Grand Avenue, Portland, OR 97232 to the attention of Glenn Taylor, Project Manager, no later than **2:00 PM on Thursday, December 22, 2005 in Conference Room 270** where bids will be publicly opened and read aloud. All contractors must submit First-Tier Subcontractor forms and MWESB Program forms in its bid submission or in a separate sealed envelope within two (2) working hours after bid closing. Forms are to list all first tier subcontractors supplying labor, or labor and materials with a contract amount greater than or equal to; 1) 5% of the project base bid, but at least \$15,000, or 2) \$350,000 regardless of the percentage.

A Pre-Bid Conference for prospective Bidders will be conducted at the Blue Lake Regional Park located at 20500 NE Marine Drive in Fairview, Oregon on **December 8, 2005 at 10:00 AM** in the Curry Building located in the park. Attendance at this meeting is mandatory for all potential prime bidders to comply with Metro's Minority, Women-Owned and Emerging Small Business Enterprise Program. A site visit is planned following the meeting.

For public improvements over \$25,000, by submitting a bid all bidders certify that they will pay and comply with the minimum prevailing wage requirements of ORS 279C.800-279C.870.

For all construction projects over \$25,000, all bidders must be licensed with the Construction Contractors Board or the State Landscape Contractors Board. (ORS 279C.365 (1)(k)).

Metro Code provisions 2.04.100 and 200 require all Bidders/Proposers to follow and document a specific good faith outreach effort to State certified Minority, Emerging and Women-owned Businesses. Certification of good faith compliance and a declaration of any actual utilization pursuant to both programs are required at the time of Bid Opening/Proposal Submission.

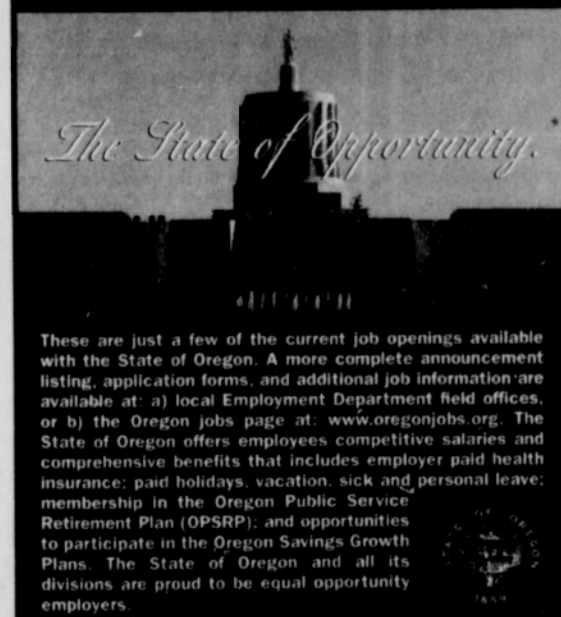
