Notice is hereby given that the City of Vancouver, Washington, will receive sealed bids up to the hour of 11:00 a.m., Pacific Standard Time, **Tuesday, May 9, 2006**, and publicly opened and read aloud at that time on the same day in Procurement Services Conference Room, 610 Esther St, 2<sup>nd</sup> Floor, Vancouver, Washington, for the following:

1. Exterior Work Will Include the Following: Demolition of Existing Exterior Stairway, ADA Accessible Walkway, New Trash Enclosure, Excavation and Backfill, New Elevator Enclosure and Lobbies, Re-Work of Underground Utilities, Partial New Roof at Elevator.

This project is financed through the Community Development Block Grant Program (CDBG) with funds obtained from the U.S. Department of Housing and Urban Development (HUD). The contract will be subject to regulations of the Departments of Labor and Housing and Urban Development.

Attention is called to Federal provisions for Equal Employment Opportunity, HUD Section 3 requirements, and the minimum wages as set forth in the contract documents.
